

SUMMARY STATISTICS

JAN. 2023

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jan. 2022 of export proceeds and import payments:

Export proceeds totaled US\$ 29,392.2 million, a decrease of US\$ 822.0 million or 2.7% (Table 1), as compared with Jan. 2022.

Import payments totaled US\$ 23,014.4 million, a decrease of US\$ 6,235.7 million or 21.3% (Table 1), as compared with Jan. 2022.

3. Comparison with Jan. 2022 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,010.9 million, a decrease of US\$ 500.4 million or 33.1% (Table 2), as compared with Jan. 2022.

Retained with exporters US\$ 28,381.3 million, a decrease of US\$ 321.6 million or 1.1% (Table 2), as compared with Jan. 2022.

4. Comparison with Jan. 2022 of import payments made:

Purchased with N.T. Dollars US\$ 3,918.4 million, a decrease of US\$ 637.2 million or 14.0% (Table 3), as compared with Jan. 2022.

Self-acquired foreign exchange imports US\$ 19,096.0 million, a decrease of US\$ 5,598.5 million or 22.7% (Table 3), as comparison with Jan. 2022.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C	US\$	1,003.4 million,	3.4% of total exports.
Usance L/C	US\$	374.8 million,	1.3% of total exports.
Collection	US\$	160.7 million,	0.5% of total exports.
Remittance	US\$	27,853.3 million,	94.8% of total exports.

(2) Imports:

Sight L/C	US\$	206.4 million,	0.9% of total imports.
Usance L/C	US\$	1,739.4 million,	7.6% of total imports.
Collection	US\$	195.8 million,	0.9% of total imports.

Remittance US\$ 20,872.8 million, 90.6% of total imports.



