

SUMMARY STATISTICS

JAN. 2006

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jan. 2005 of export proceeds and import payments:

Export proceeds totaled US\$ 16,892.9 million, a decrease of US\$ 105.6 million or 0.6% (Table 1), as compared with Jan. 2005.

Import payments totaled US\$ 17,224.0 million, an increase of US\$ 687.7 million or 4.2% (Table 1), as compared with Jan. 2005.

3. Comparison with Jan. 2005 of export proceeds realized:

Sold for N.T. Dollars US\$ 2,172.6 million, a decrease of US\$ 8.5 million or 0.4% (Table 2), as compared with Jan. 2005.

Retained with exporters US\$ 14,720.3 million, a decrease of US\$ 97.1 million or 0.7% (Table 2), as compared with Jan. 2005.

4. Comparison with Jan. 2005 of import payments made:

Purchased with N.T. Dollars: US\$ 3,990.1 million, an increase of US\$ 16.0 million or 0.4% (Table 3), as compared with Jan. 2005.

Self-acquired foreign exchange imports US\$ 13,233.9 million, an increase of US\$ 671.7 million or 5.3% (Table 3), as compared with Jan. 2005.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 1,658.8 million, 9.8% of total exports.

Usance L/C US\$ 819.8 million, 4.9% of total exports.

Collection US\$ 329.1 million, 1.9% of total exports.

Remittance US\$ 14,085.2 million, 83.4% of total exports.

(2) Imports:

Sight L/C US\$ 366.6 million, 2.1% of total imports.

Usance L/C US\$ 3,602.3 million, 20.9% of total imports.

Collection US\$ 266.4 million, 1.5% of total imports.

Remittance US\$ 12,988.7 million, 75.5% of total imports.

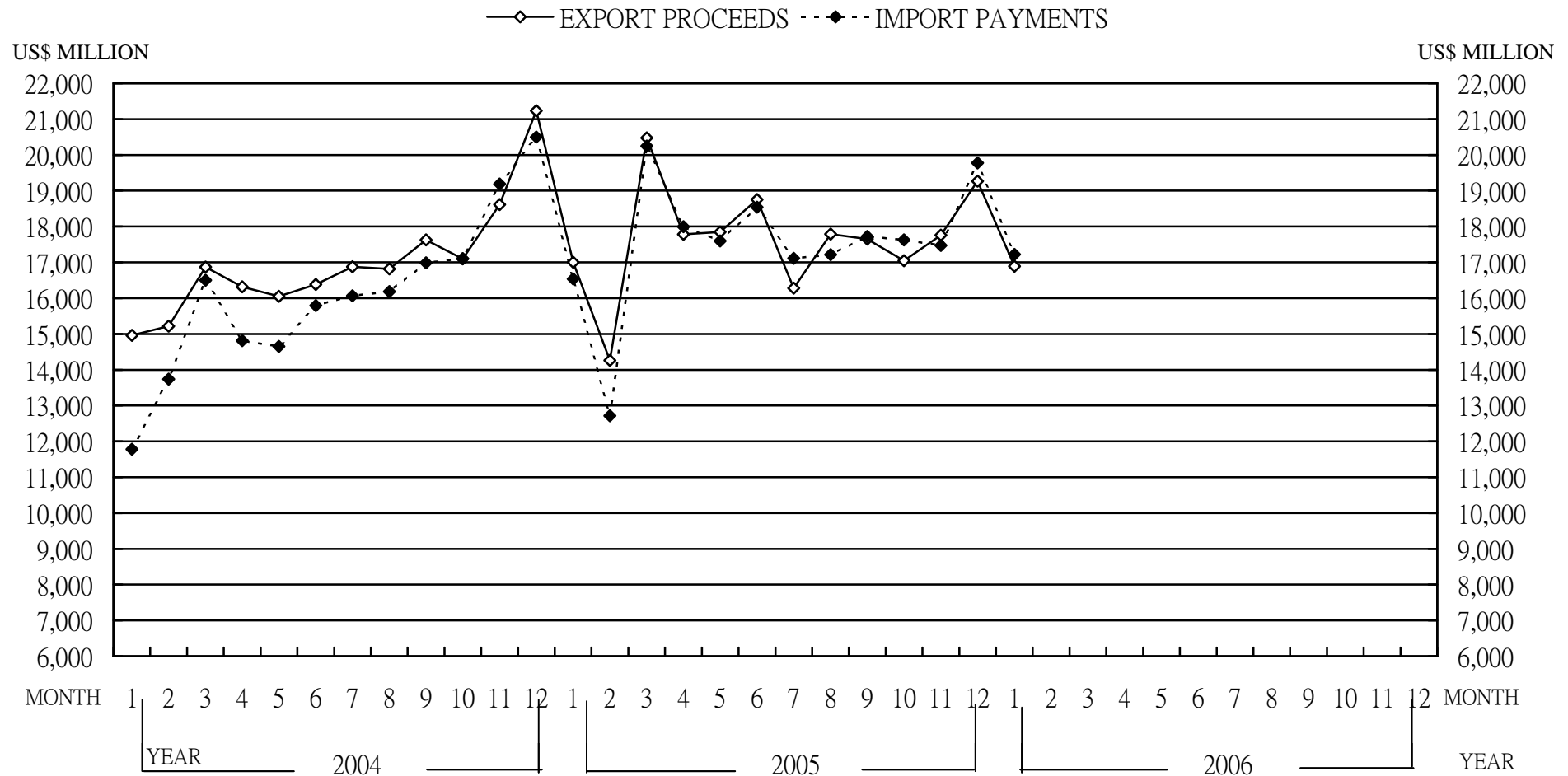
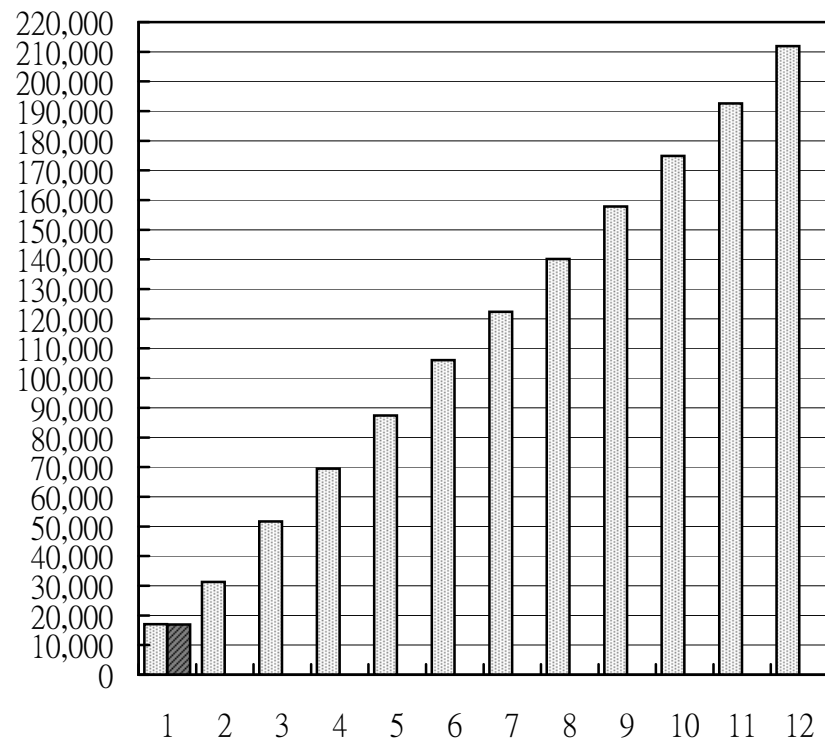
