

SUMMARY STATISTICS

DEC. 2005

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Dec. 2004 of export proceeds and import payments:

Export proceeds totaled US\$ 19,264.9 million, a decrease of US\$ 1,970.3 million or 9.3% (Table 1), as compared with Dec. 2004.

Import payments totaled US\$ 19,773.5 million, a decrease of US\$ 727.8 million or 3.6% (Table 1), as compared with Dec. 2004.

3. Comparison with Dec. 2004 of export proceeds realized:

Sold for N.T. Dollars US\$ 2,101.6 million, a decrease of US\$ 418.0 million or 16.6% (Table 2), as compared with Dec. 2004.

Retained with exporters US\$ 17,163.3 million, a decrease of US\$ 1,552.3 million or 8.3% (Table 2), as compared with Dec. 2004.

4. Comparison with Dec. 2004 of import payments made:

Purchased with N.T. Dollars: US\$ 4,694.6 million, a decrease of US\$ 36.1 million or 0.8% (Table 3), as compared with Dec. 2004.

Self-acquired foreign exchange imports US\$ 15,078.9 million, a decrease of US\$ 691.7 million or 4.4% (Table 3), as compared with Dec. 2004.

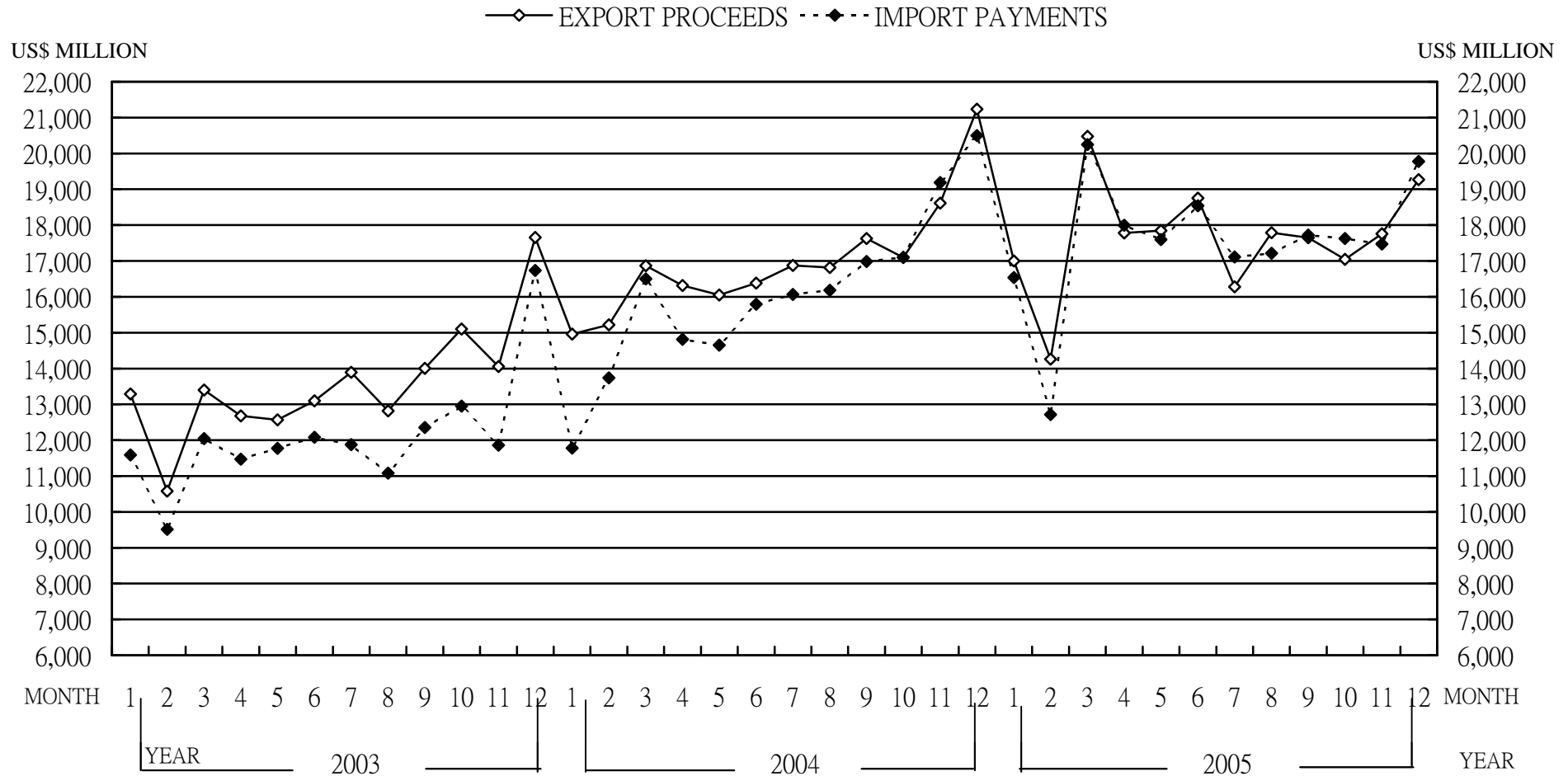
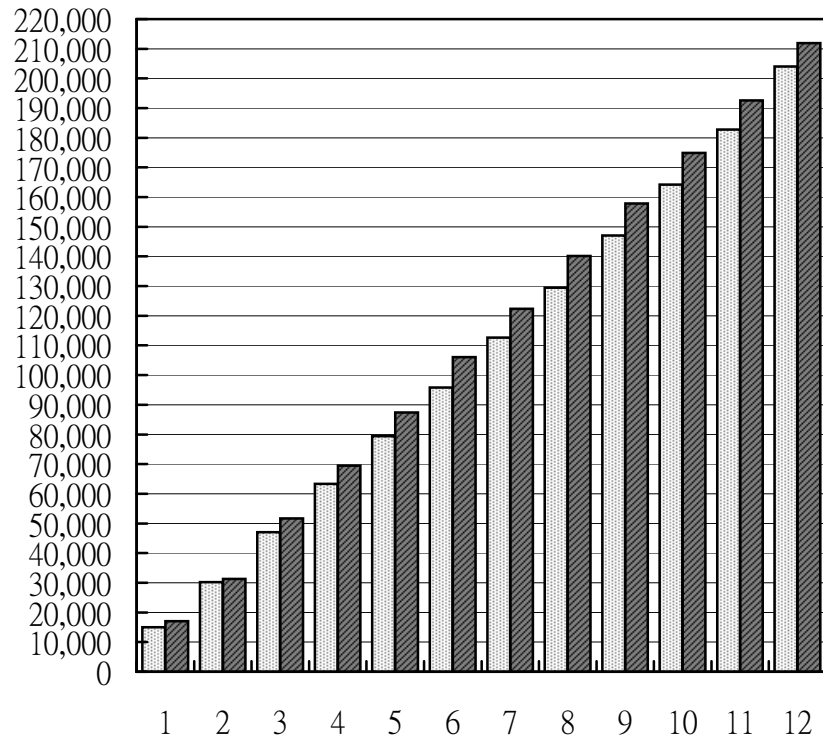
