

SUMMARY STATISTICS

JUN. 2005

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jun. 2004 of export proceeds and import payments:

Export proceeds totaled US\$ 18,811.0 million, an increase of US\$ 2,426.4 million or 14.8% (Table 1), as compared with Jun. 2004.

Import payments totaled US\$ 18,545.1 million, an increase of US\$ 2,750.2 million or 17.4% (Table 1), as compared with Jun. 2004.

3. Comparison with Jun. 2004 of export proceeds realized:

Sold for N.T. Dollars US\$ 2,419.4 million, an increase of US\$ 75.3 million or 3.2% (Table 2), as compared with Jun. 2004.

Retained with exporters US\$ 16,391.6 million, an increase of US\$ 2,351.1 million or 16.7% (Table 2), as compared with Jun. 2004.

4. Comparison with Jun. 2004 of import payments made:

Purchased with N.T. Dollars: US\$ 4,185.5 million, an increase of US\$ 273.7 million or 7.0% (Table 3), as compared with Jun. 2004.

Self-acquired foreign exchange imports US\$ 14,359.6 million, an increase of US\$ 2,476.5 million or 20.8% (Table 3), as compared with Jun. 2004.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 1,886.8 million, 10.0% of total exports.

Usance L/C US\$ 739.4 million, 3.9% of total exports.

Collection US\$ 426.0 million, 2.3% of total exports.

Remittance US\$ 15,758.8 million, 83.8% of total exports.

(2) Imports:

Sight L/C US\$ 537.2 million, 2.9% of total imports.

Usance L/C US\$ 4,100.8 million, 22.1% of total imports.

Collection US\$ 298.6 million, 1.6% of total imports.

Remittance US\$ 13,608.5 million, 73.4% of total imports.

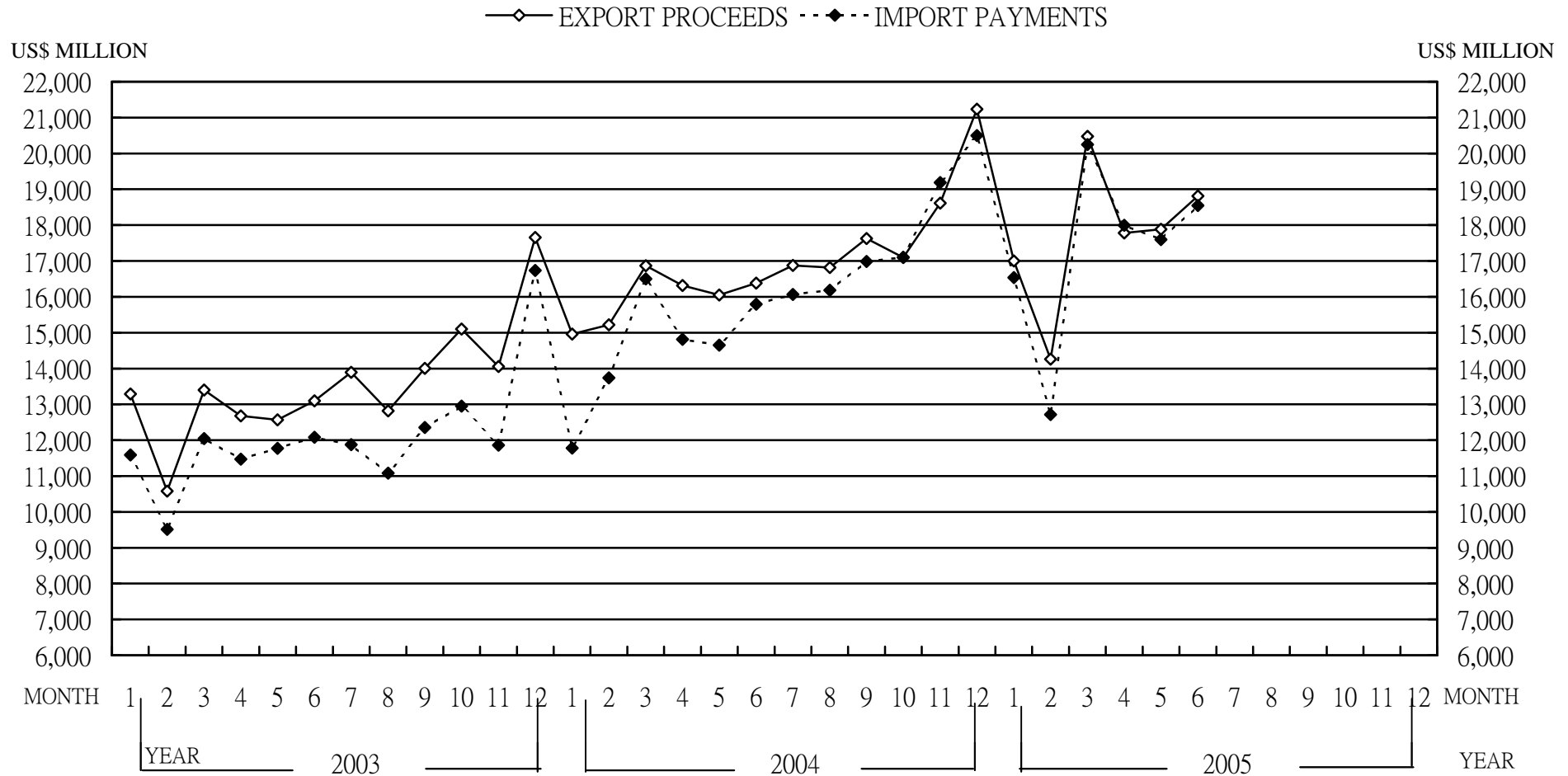
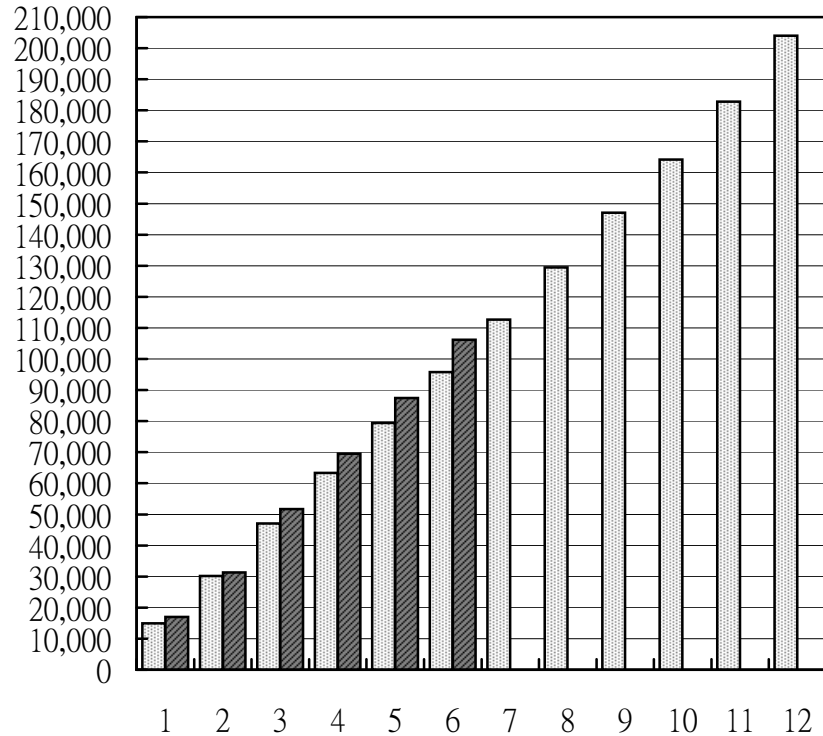
