

# SUMMARY STATISTICS

APR. 2005

**1. Coverage of Statistics:**

All foreign exchange export proceeds and import payments through banks.

**2. Comparison with Apr. 2004 of export proceeds and import payments:**

Export proceeds totaled US\$ 17,787.7 million, an increase of US\$ 1,471.0 million or 9.0% (Table 1), as compared with Apr. 2004.

Import payments totaled US\$ 18,047.7 million, an increase of US\$ 3,236.3 million or 21.9% (Table 1), as compared with Apr. 2004.

**3. Comparison with Apr. 2004 of export proceeds realized:**

Sold for N.T. Dollars US\$ 2,201.1 million, a decrease of US\$ 70.1 million or 3.1% (Table 2), as compared with Apr. 2004.

Retained with exporters US\$ 15,586.6 million, an increase of US\$ 1,541.1 million or 11.0% (Table 2), as compared with Apr. 2004.

**4. Comparison with Apr. 2004 of import payments made:**

Purchased with N.T. Dollars: US\$ 3,986.3 million, an increase of US\$ 367.1 million or 10.1% (Table 3), as compared with Apr. 2004.

Self-acquired foreign exchange imports US\$ 14,061.4 million, an increase of US\$ 2,869.2 million or 25.6% (Table 3), as compared with Apr. 2004.

**5. Foreign exchange exports and imports by type of payment (Table 4):**

(1) Exports:

Sight L/C US\$ 1,774.5 million, 10.0% of total exports.

Usance L/C US\$ 684.4 million, 3.8% of total exports.

Collection US\$ 384.4 million, 2.2% of total exports.

Remittance US\$ 14,944.4 million, 84.0% of total exports.

(2) Imports:

Sight L/C US\$ 511.7 million, 2.8% of total imports.

Usance L/C US\$ 3,834.7 million, 21.2% of total imports.

Collection US\$ 248.6 million, 1.4% of total imports.

Remittance US\$ 13,452.7 million, 74.6% of total imports.

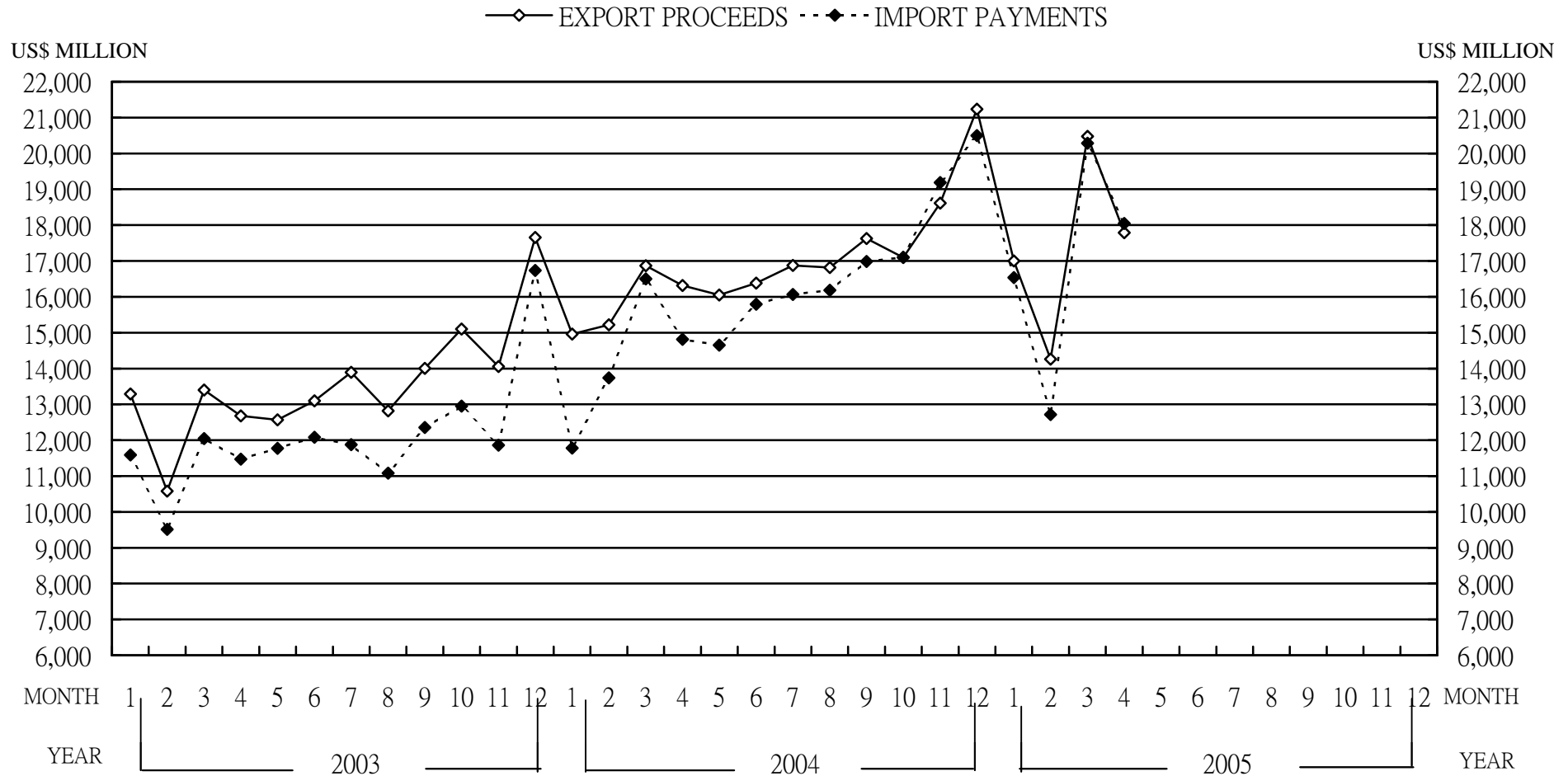
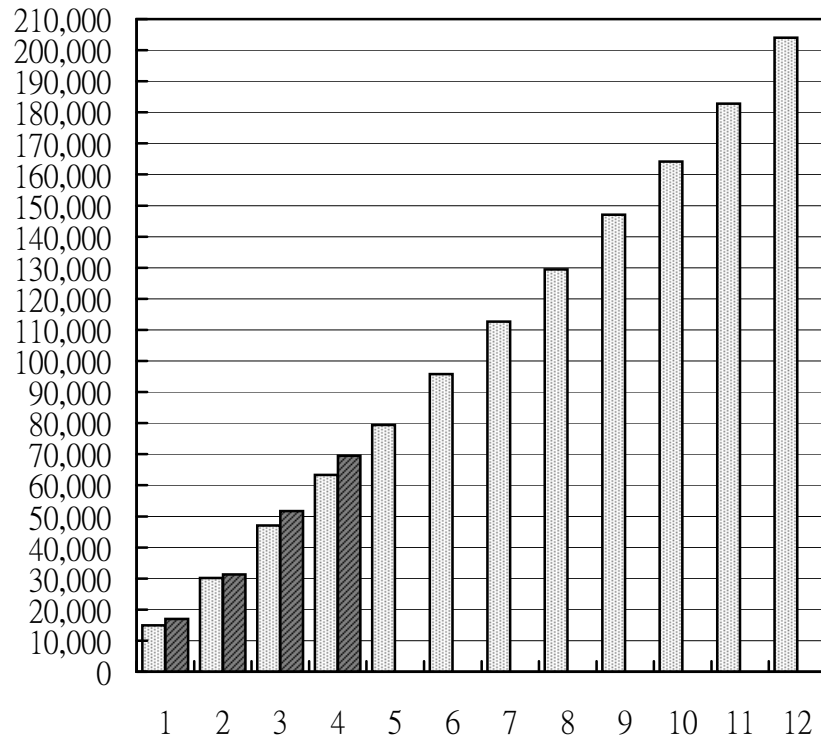
