## JAN. 2005

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.
2. Comparison with Jan. 2004 of export proceeds and import payments:

Export proceeds totaled US\$ 17,002.7 million, an increase of US\$ 2,044.3 million or $\mathbf{1 3 . 7 \%}$ (Table 1), as compared with Jan. 2004.
Import payments totaled US\$ $\mathbf{1 6 , 5 3 6 . 8}$ million, an increase of US\$ $4,760.1$ million or $40.4 \%$ (Table 1 ), as compared with Jan. 2004.
3. Comparison with Jan. 2004 of export proceeds realized:

Sold for N.T. Dollars US\$ 2,181.1 million, an increase of US\$ 79.5 million or $\mathbf{3 . 8 \%}$ (Table 2), as compared with Jan. 2004.
Retained with exporters US\$ $14,821.6$ million, an increase of US\$ $\mathbf{1 , 9 6 4 . 8}$ million or $\mathbf{1 5 . 3 \%}$ (Table 2), as compared with Jan. 2004.
4. Comparison with Jan. 2004 of import payments made:

Purchased with N.T. Dollars: US\$ 3,974.1 million, an increase of US\$ $\mathbf{8 4 9 . 0}$ million or $\mathbf{2 7 . 2 \%}$ (Table 3), as compared with Jan. 2004.
Self-acquired foreign exchange imports US\$ $\mathbf{1 2 , 5 6 2 . 7}$ million, an increase of US\$ 3,911.1 million or $\mathbf{4 5 . 2 \%}$ (Table 3), as compared with Jan. 2004.
