1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.
2. Comparison with Oct. 2002 of export proceeds and import payments:

Export proceeds totaled US\$ 15,103.7 million, an increase of US\$ $\mathbf{2 , 2 5 4 . 9}$ million or $\mathbf{1 7 . 5 \%}$ (Table 1), as compared with Oct. 2002.
Import payments totaled US\$ $\mathbf{1 3 , 4 4 6 . 6}$ million, an increase of US\$ $\mathbf{1 , 7 5 8 . 6}$ million or $\mathbf{1 5 . 0 \%}$ (Table 1), as compared with Oct. 2002.
3. Comparison with Oct. 2002 of export proceeds realized:

Sold for N.T. Dollars US $\$ 2,394.0$ million, an increase of US\$ $\mathbf{3 6 8 . 0}$ million or $\mathbf{1 8 . 2 \%}$ (Table 2), as compared with Oct. 2002.
Retained with exporters US\$ $12,709.7$ million, an increase of US\$ $\mathbf{1 , 8 8 6 . 9}$ million or $\mathbf{1 7 . 4 \%}$ (Table 2 ), as compared with Oct. 2002.
4. Comparison with Oct. 2002 of import payments made:

Purchased with N.T. Dollars: US $\$ 3,129.4$ million, a decrease of US\$ 331.7 million or $9.6 \%$ (Table 3), as compared with Oct. 2002.
Self-acquired foreign exchange imports US\$ $\mathbf{1 0 , 3 1 7 . 2}$ million, an increase of US\$ $\mathbf{2 , 0 9 0 . 3}$ million or $\mathbf{2 5 . 4 \%}$ (Table 3), as compared with Oct. 2002.
