

SUMMARY STATISTICS

JUL. 2003

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jul. 2002 of export proceeds and import payments:

Export proceeds totaled US\$ 13,897.9 million, an increase of US\$ 763.4 million or 5.8% (Table 1), as compared with Jul. 2002.

Import payments totaled US\$ 11,931.9 million, an increase of US\$ 1,079.0 million or 9.9% (Table 1), as compared with Jul. 2002.

3. Comparison with Jul. 2002 of export proceeds realized:

Sold for N.T. Dollars US\$ 2,130.7 million, a decrease of US\$ 640.6 million or 23.1% (Table 2), as compared with Jul. 2002.

Retained with exporters US\$ 11,767.2 million, an increase of US\$ 1,404.0 million or 13.5% (Table 2), as compared with Jul. 2002.

4. Comparison with Jul. 2002 of import payments made:

Purchased with N.T. Dollars: US\$ 3,429.2 million, an increase of US\$ 312.7 million or 10.0 % (Table 3), as compared with Jul. 2002.

Self-acquired foreign exchange imports US\$ 8,502.7 million, an increase of US\$ 766.3 million or 9.9 % (Table 3), as compared with Jul. 2002.

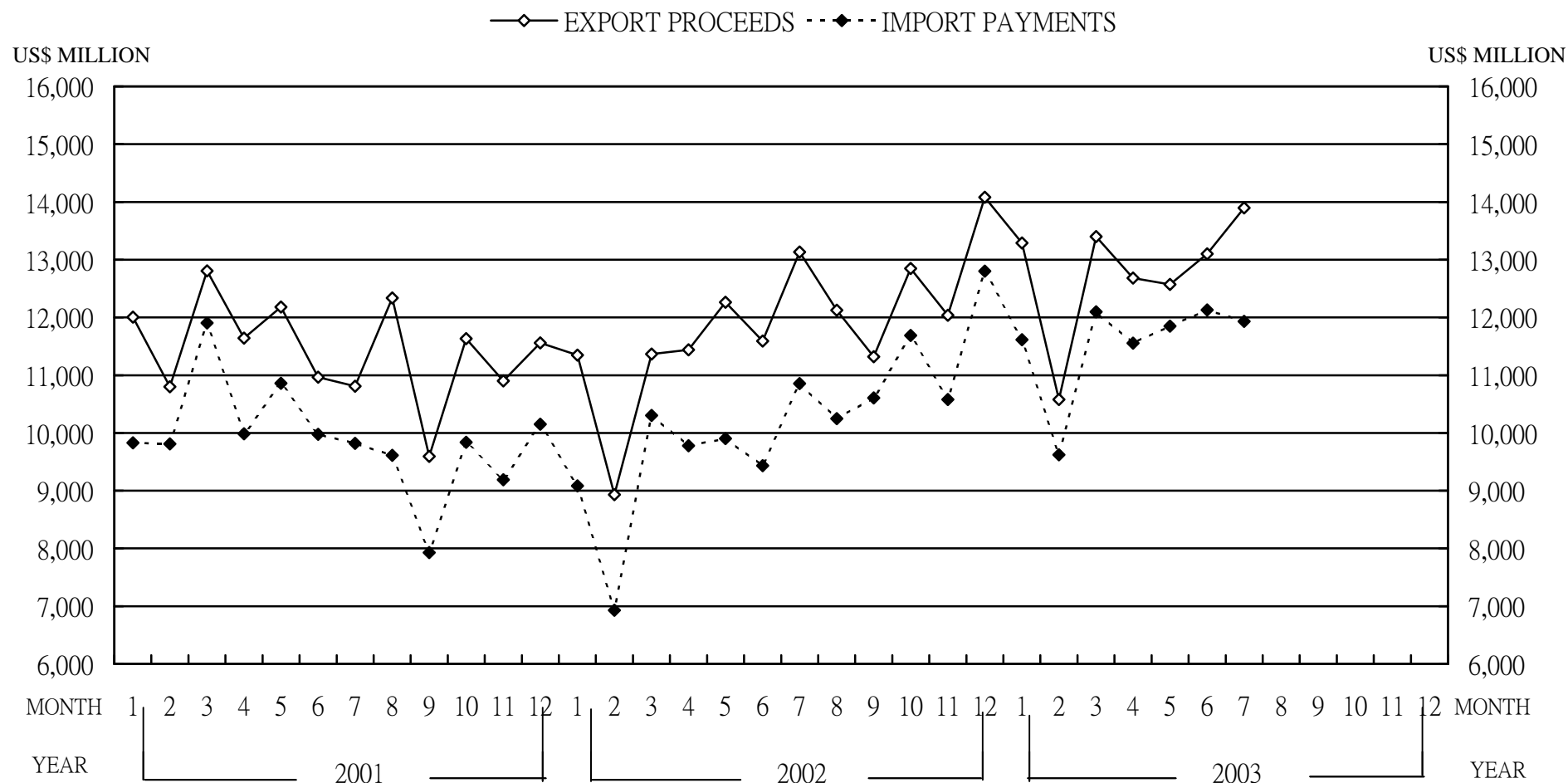
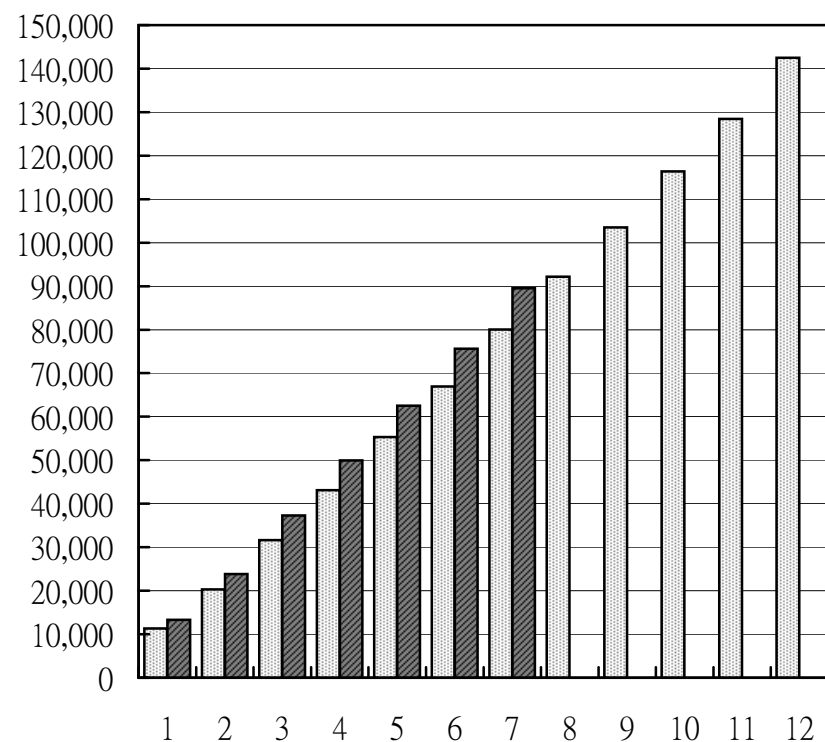
