- 1. Coverage of Statistics:
 - All foreign exchange export proceeds and import payments through banks.
- 2. Comparison with Feb. 2003 of export proceeds and import payments:
- Export proceeds totaled US\$ 15,250.1 million, an increase of US\$ 4,670.2 million or 44.1% (Table 1), as compared with Feb. 2003.

Import payments totaled US\$ 13,743.1 million, an increase of US\$ 4,232.9 million or 44.5% (Table 1), as compared with Feb. 2003.

3. Comparison with Feb. 2003 of export proceeds realized: Sold for N.T. Dollars US\$ 2,133.2 million, an increase of US\$ 588.2 million or 38.1% (Table 2), as compared with Feb. 2003.

Retained with exporters US\$ 13,116.9 million, an increase of US\$ 4,082.0 million or 45.2% (Table 2), as compared with Feb. 2003.

4. Comparison with Feb. 2003 of import payments made:

Purchased with N.T. Dollars: US\$ 3,415.6 million, an increase of US\$ 879.6 million or 34.7% (Table 3), as compared with Feb. 2003.

Self-acquired foreign exchange imports US\$ 10,327.5 million, an increase of US\$ 3,353.3 million or 48.1% (Table 3), as compared with Feb. 2003.



→ EXPORT PROCEEDS - - ◆ - - IMPORT PAYMENTS




