

SUMMARY STATISTICS

NOV. 2003

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Nov. 2002 of export proceeds and import payments:

Export proceeds totaled US\$ 14,055.9 million, an increase of US\$ 2,016.3 million or 16.7% (Table 1), as compared with Nov. 2002.

Import payments totaled US\$ 11,865.9 million, an increase of US\$ 1,285.6 million or 12.2% (Table 1), as compared with Nov. 2002.

3. Comparison with Nov. 2002 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,962.5 million, an increase of US\$ 84.0 million or 4.5% (Table 2), as compared with Nov. 2002.

Retained with exporters US\$ 12,093.4 million, an increase of US\$ 1,932.3 million or 19.0% (Table 2), as compared with Nov. 2002.

4. Comparison with Nov. 2002 of import payments made:

Purchased with N.T. Dollars: US\$ 3,093.3 million, a decrease of US\$ 94.7 million or 3.0% (Table 3), as compared with Nov. 2002.

Self-acquired foreign exchange imports US\$ 8,772.6 million, an increase of US\$ 1,380.3 million or 18.7% (Table 3), as compared with Nov. 2002.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 1,363.4 million, 9.7% of total exports.

Usance L/C US\$ 549.1 million, 3.9% of total exports.

Collection US\$ 327.6 million, 2.3% of total exports.

Remittance US\$ 11,815.8 million, 84.1% of total exports.

(2) Imports:

Sight L/C US\$ 287.7 million, 2.4% of total imports.

Usance L/C US\$ 2,429.3 million, 20.5% of total imports.

Collection US\$ 256.7 million, 2.2% of total imports.

Remittance US\$ 8,892.2 million, 74.9% of total imports.

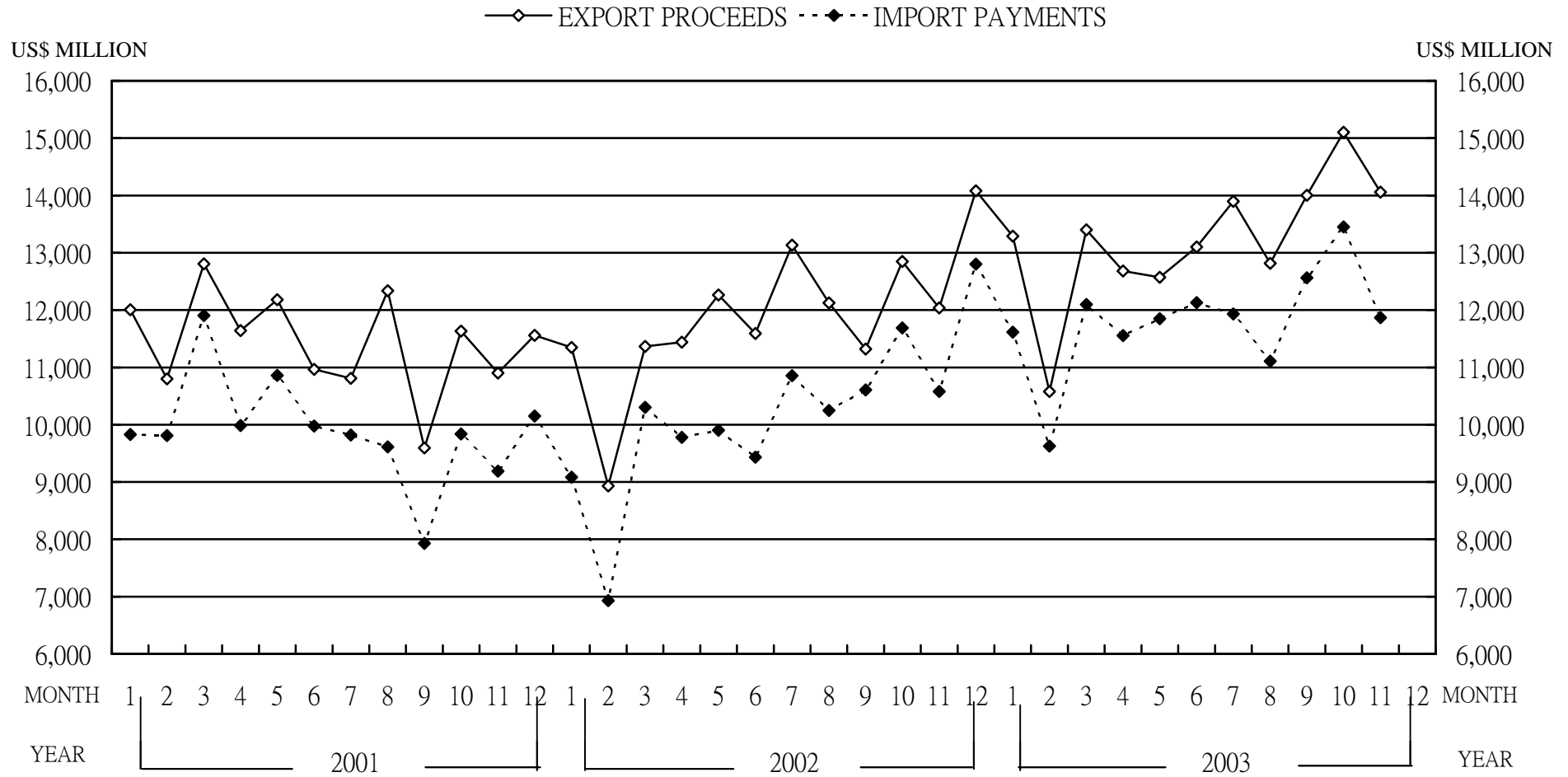
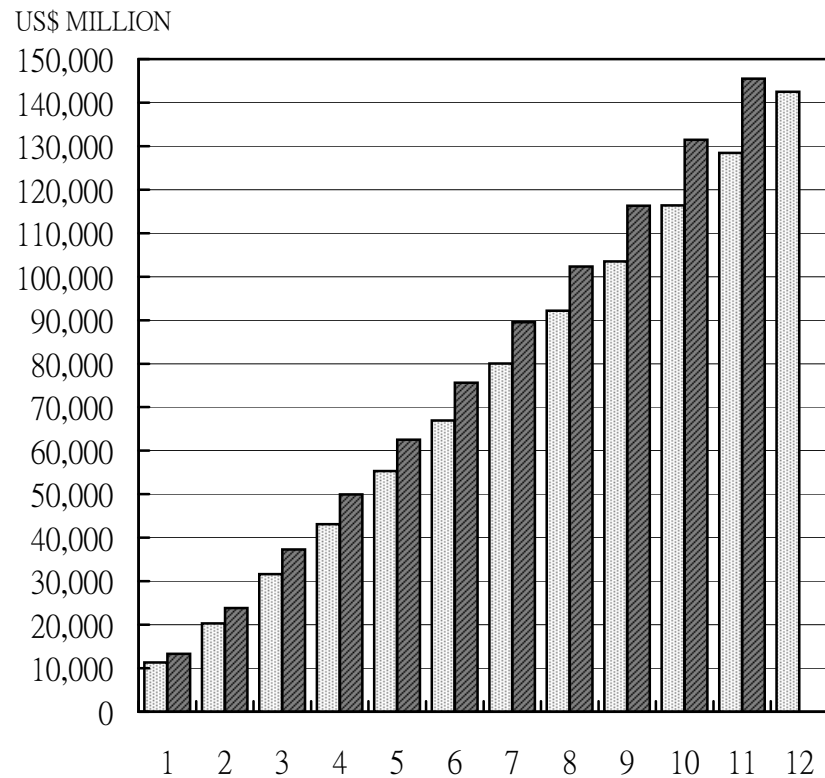
