

SUMMARY STATISTICS

APR. 2003

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with **Apr. 2002 of export proceeds and import payments:**

Export proceeds totaled US\$ 12,691.8 million, a increase of US\$ 1,252.3 million or 10.9% (Table 1), as compared with Apr. 2002.

Import payments totaled US\$ 11,556.7 million, a increase of US\$ 1,780.1 million or 18.2% (Table 1), as compared with Apr. 2002.

3. Comparison with **Apr. 2002 of export proceeds realized:**

Sold for N.T. Dollars US\$ 2,030.2 million, a increase of US\$ 66.7 million or 3.4% (Table 2), as compared with Apr. 2002.

Retained with exporters US\$ 10,661.6 million, an increase of US\$ 1,185.6 million or 12.5% (Table 2), as compared with Apr. 2002.

4. Comparison with **Apr. 2002 of import payments made:**

Purchased with N.T. Dollars: US\$ 3,219.2 million, a increase of US\$ 422.7 million or 15.1% (Table 3), as compared with Apr. 2002.

Self-acquired foreign exchange imports US\$ 8,337.5 million, an increase of US\$ 1,357.4 million or 19.4% (Table 3), as compared with Apr. 2002.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ **1,451.9** million, **11.4%** of total exports.

Usance L/C US\$ **571.1** million, **4.5%** of total exports.

Collection US\$ **344.8** million, **2.7%** of total exports.

Remittance US\$ **10,324.0** million, **81.4%** of total exports.

(2) Imports:

Sight L/C US\$ **386.4** million, **3.3%** of total imports.

Usance L/C US\$ **2,581.9** million, **22.3%** of total imports.

Collection US\$ **221.3** million, **1.9%** of total imports.

Remittance US\$ **8,367.1** million, **72.5%** of total imports.

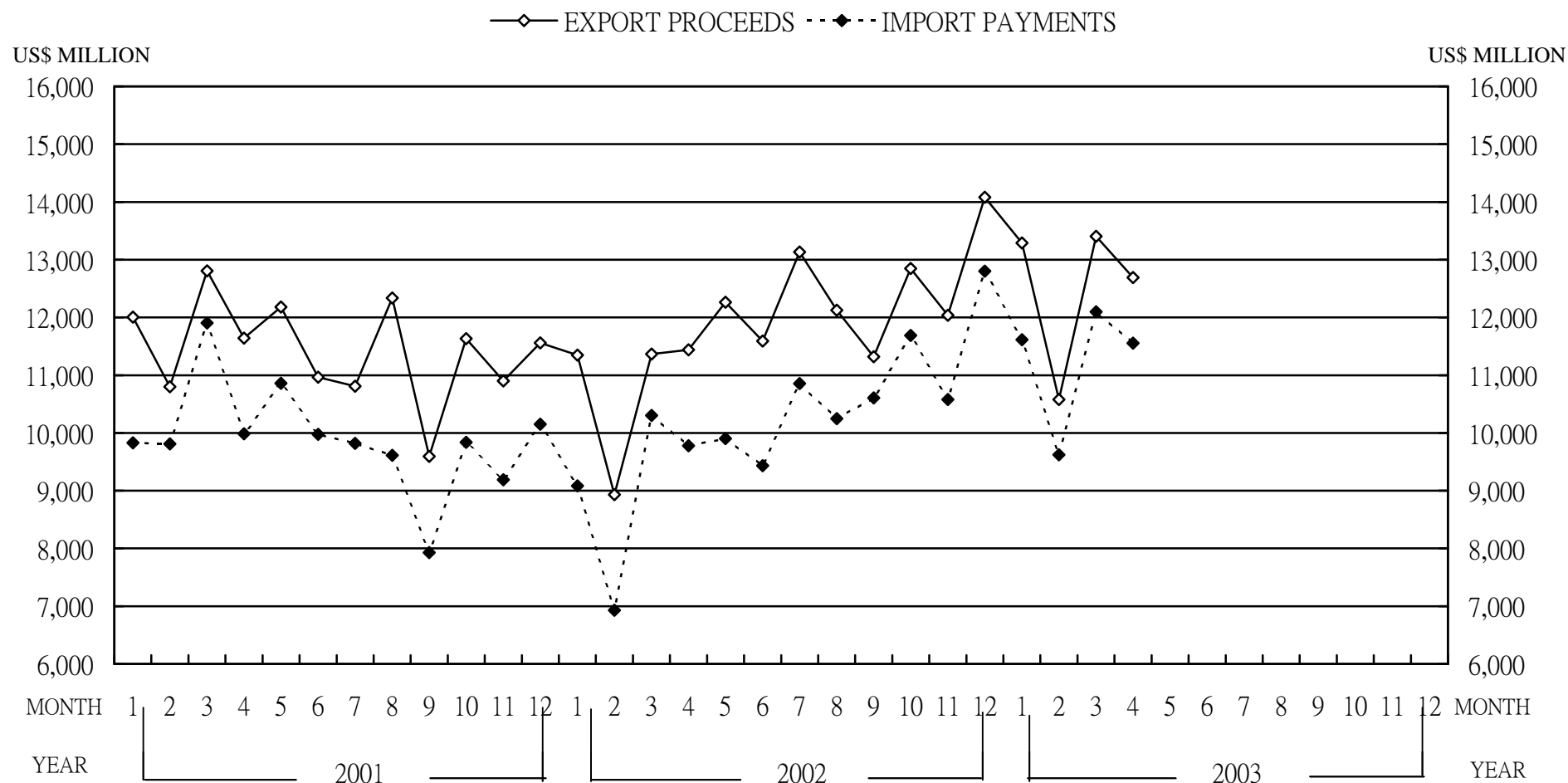
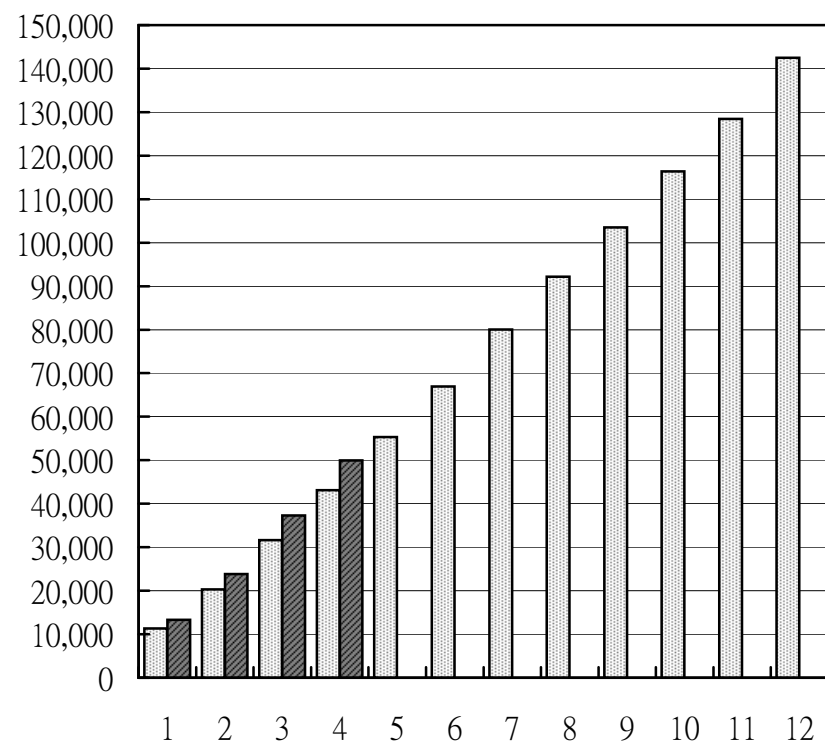
