

SUMMARY STATISTICS

JAN. 2002

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jan. 2001 of export proceeds and import payments:

Export proceeds totaled US\$11,347.0 million, a decrease of US\$659.2 million or 5.5% (Table 1), as compared with Jan. 2001.

Import payments totaled US\$ 9,086.7 million, a decrease of US\$ 743.9 million or 7.6% (Table 1), as compared with Jan. 2001.

3. Comparison with Jan. 2001 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,836.4 million, a decrease of US\$393.5 million or 17.6% (Table 2), as compared with Jan. 2001.

Retained with exporters US\$ 9,510.6 million, a decrease of US\$265.7 million or 2.7% (Table 2), as compared with Jan. 2001.

4. Comparison with Jan. 2001 of import payments made:

Purchased with N.T. Dollars: US\$2,869.6 million, a decrease of US\$588.2 million or 17.0% (Table 3), as compared with Jan. 2001.

Self-acquired foreign exchange imports US\$6,217.1 million, a decrease of US\$155.7 million or 2.4% (Table 3), as compared with Jan. 2001.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C	US\$	1,397.9 million,	12.3% of total exports.
Usance L/C	US\$	475.2 million,	4.2% of total exports.
Collection	US\$	345.9 million,	3.0% of total exports.
Remittance	US\$	9,128.0 million,	80.5% of total exports.

(2) Imports:

Sight L/C	US\$	381.5 million,	4.2% of total imports.
Usance L/C	US\$	2,082.0 million,	22.9% of total imports.
Collection	US\$	255.9 million,	2.8% of total imports.
Remittance	US\$	6,367.3 million,	70.1% of total imports.

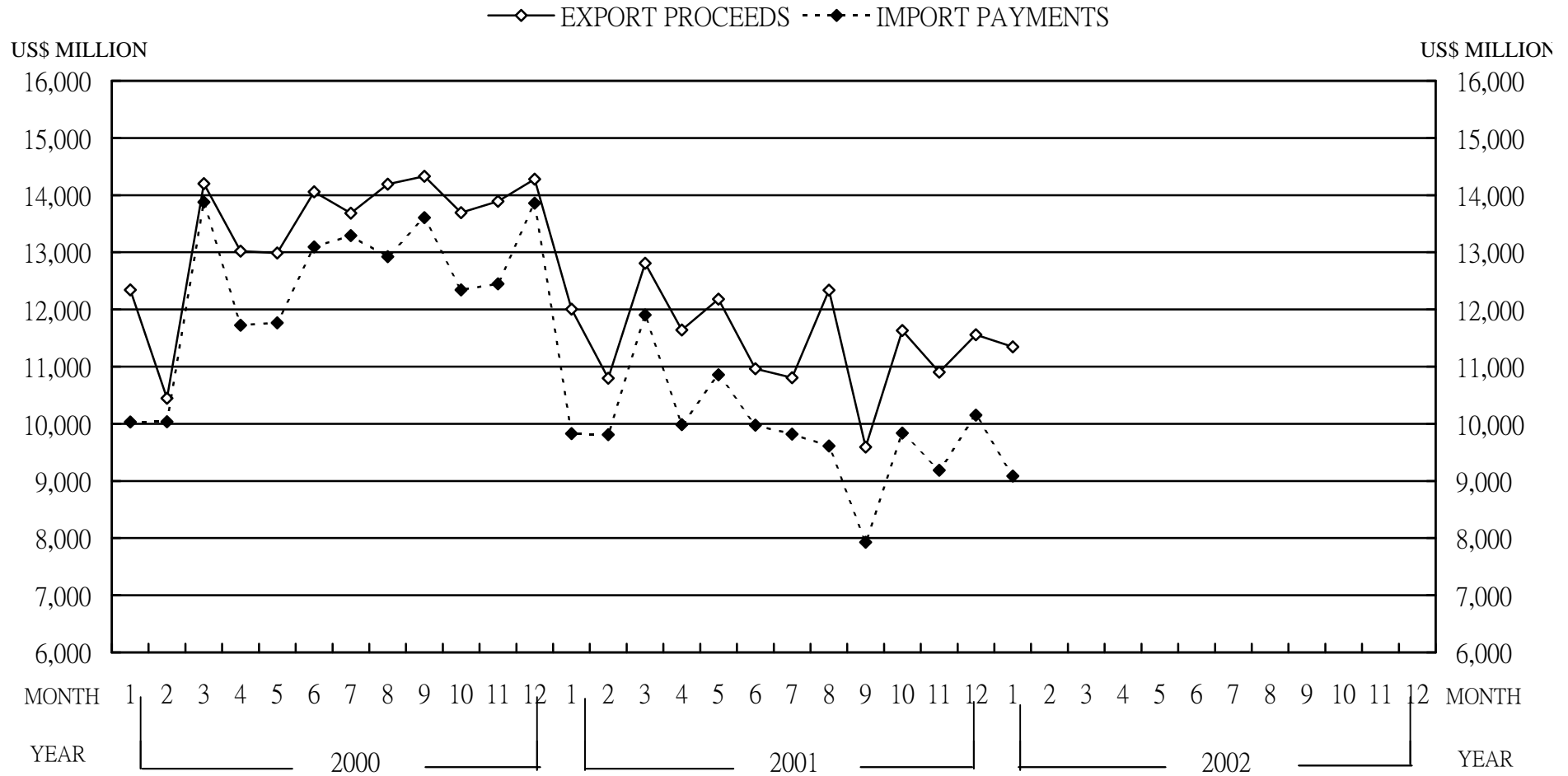
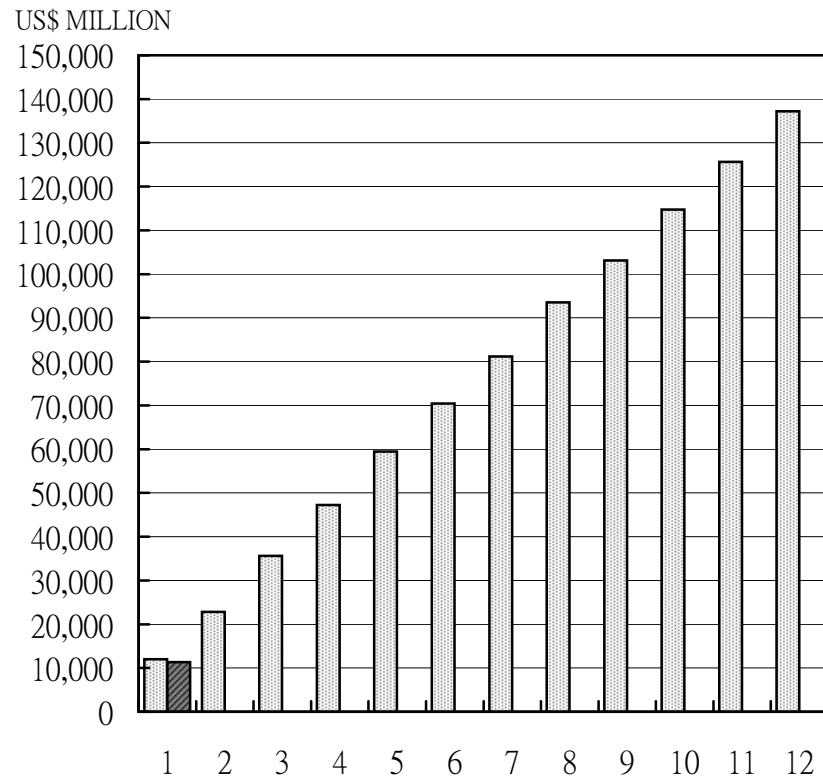
