

SUMMARY STATISTICS

MAY 2011

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with May 2010 of export proceeds and import payments:

Export proceeds totaled US\$27,149.0 million, an increase of US\$4,008.0 million or 17.3% (Table 1), as compared with May 2010.

Import payments totaled US\$ 25,519.6 million, an increase of US\$ 5,475.6 million or 27.3% (Table 1), as compared with May 2010.

3. Comparison with May 2010 of export proceeds realized:

Sold for N.T. Dollars US\$ 2,250.8 million, an increase of US\$ 132.5 million or 6.3% (Table 2), as compared with May 2010.

Retained with exporters US\$ 24,898.2 million, an increase of US\$ 3,875.5 million or 18.4% (Table 2), as compared with May 2010.

4. Comparison with May 2010 of import payments made:

Purchased with N.T. Dollars US\$ 4,556.1 million, an increase of US\$ 1,113.6 million or 32.3% (Table 3), as compared with May 2010.

Self-acquired foreign exchange imports US\$ 20,963.5 million, an increase of US\$ 4,362.0 million or 26.3% (Table 3), as compared with May 2010.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 2,414.0 million, 8.9% of total exports.

Usance L/C US\$ 788.9 million, 2.9% of total exports.

Collection US\$ 392.8 million, 1.4% of total exports.

Remittance US\$ 23,553.3 million, 86.8% of total exports.

(2) Imports:

Sight L/C US\$ 588.5 million, 2.3% of total imports.

Usance L/C US\$ 3,375.9 million, 13.2% of total imports.

Collection US\$ 236.4 million, 0.9% of total imports.

Remittance US\$ 21,318.8 million, 83.6% of total imports.

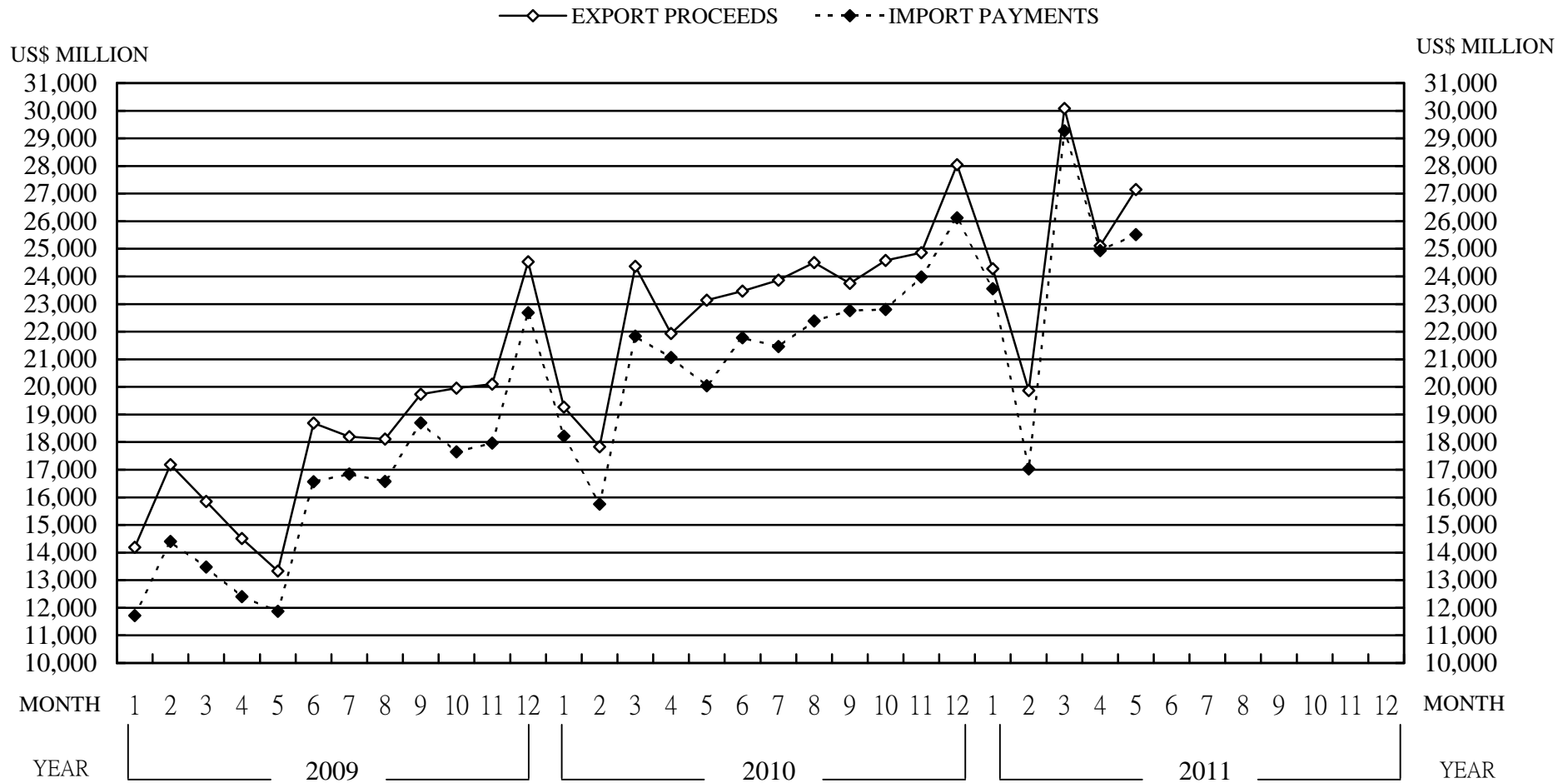
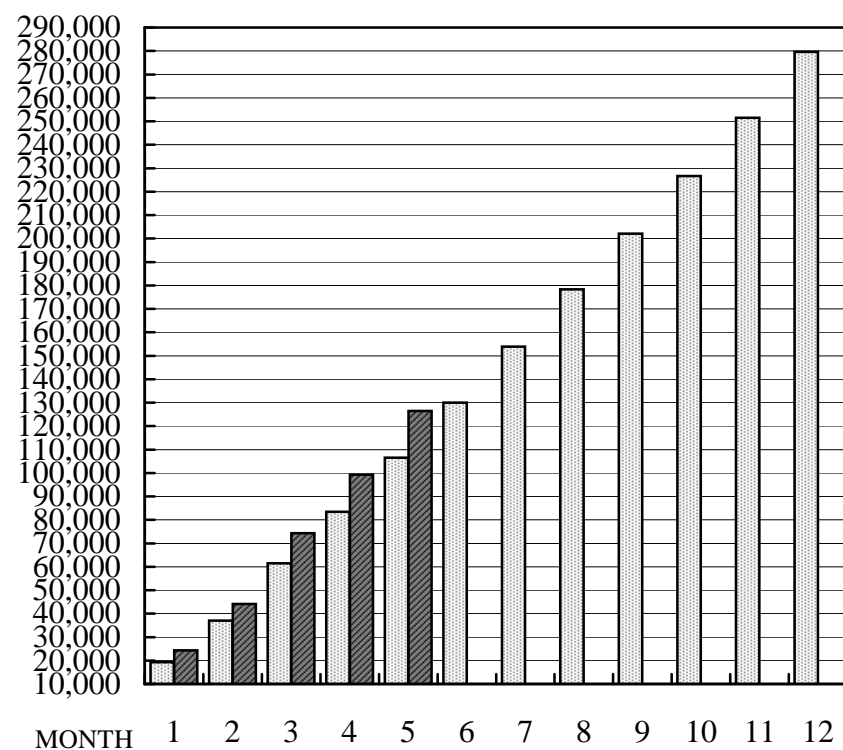
