

SUMMARY STATISTICS

JUN. 2010

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jun. 2009 of export proceeds and import payments:

Export proceeds totaled US\$ 23,485.9 million, an increase of US\$ 4,794.0 million or 25.6% (Table 1), as compared with Jun. 2009.

Import payments totaled US\$ 21,778.3 million, an increase of US\$ 5,208.2 million or 31.4% (Table 1), as compared with Jun. 2009.

3. Comparison with Jun. 2009 of export proceeds realized:

Sold for N.T. Dollars US\$ 2,011.7 million, an increase of US\$ 134.3 million or 7.2% (Table 2), as compared with Jun. 2009.

Retained with exporters US\$ 21,474.2 million, an increase of US\$ 4,659.7 million or 27.7% (Table 2), as compared with Jun. 2009.

4. Comparison with Jun. 2009 of import payments made:

Purchased with N.T. Dollars US\$ 4,037.4 million, an increase of US\$ 647.1 million or 19.1% (Table 3), as compared with Jun. 2009.

Self-acquired foreign exchange imports US\$ 17,740.9 million, an increase of US\$ 4,561.1 million or 34.6% (Table 3), as compared with Jun. 2009.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 1,730.0 million, 7.4% of total exports.

Usance L/C US\$ 1,017.0 million, 4.3% of total exports.

Collection US\$ 387.0 million, 1.6% of total exports.

Remittance US\$ 20,351.9 million, 86.7% of total exports.

(2) Imports:

Sight L/C US\$ 565.4 million, 2.6% of total imports.

Usance L/C US\$ 2,985.0 million, 13.7% of total imports.

Collection US\$ 221.6 million, 1.0% of total imports.

Remittance US\$ 18,006.3 million, 82.7% of total imports.

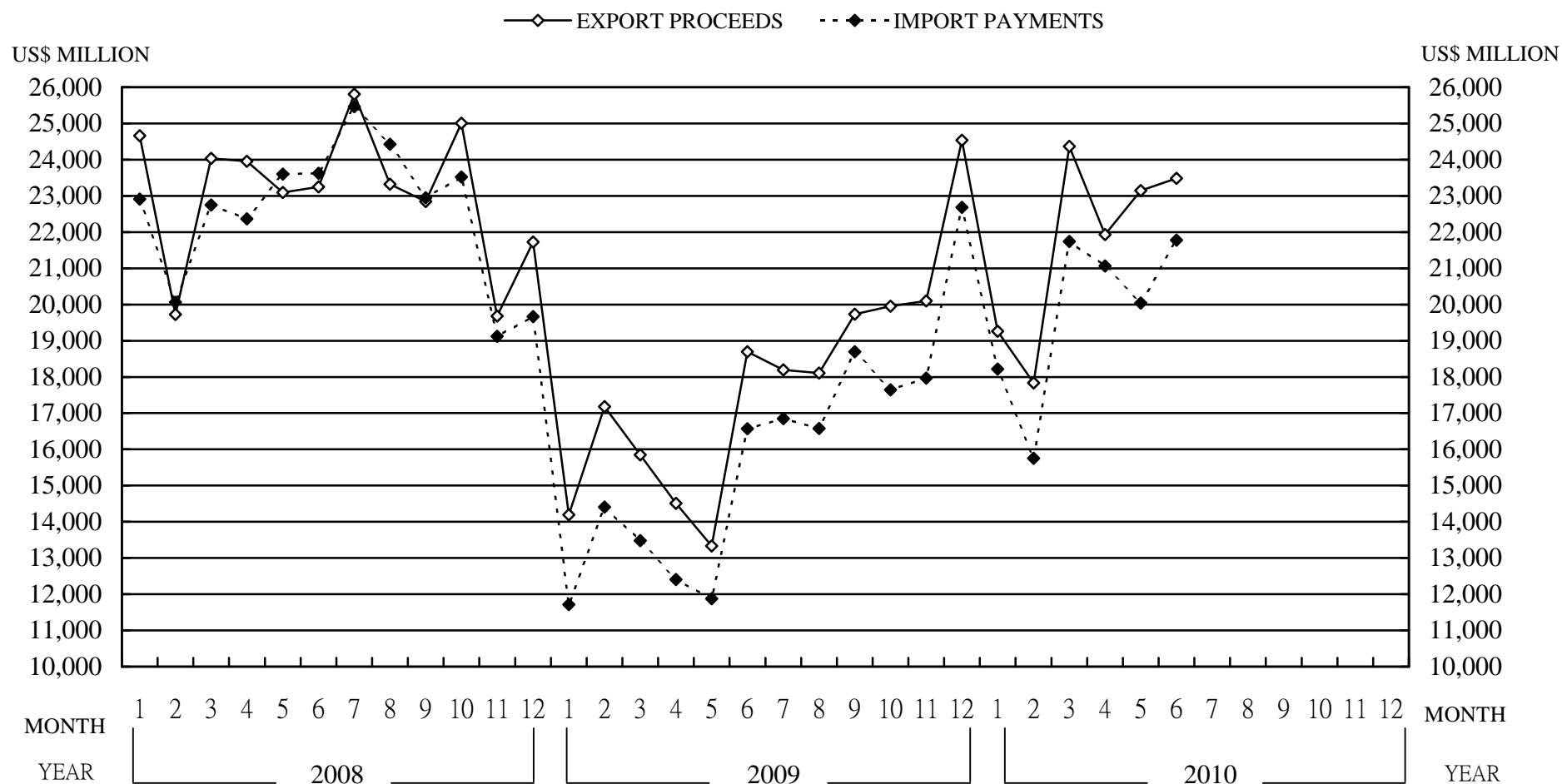
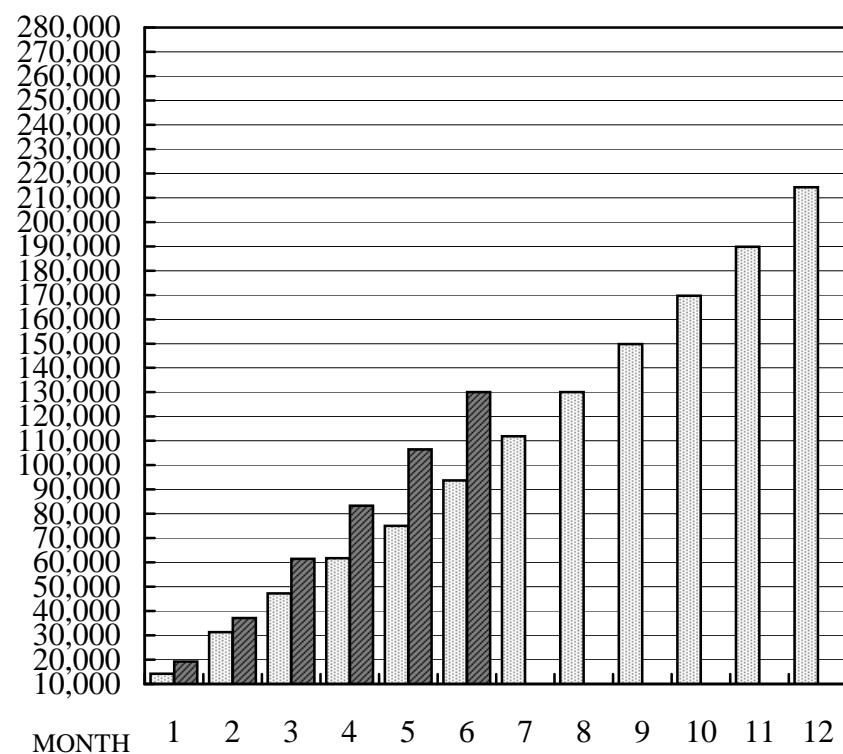
