

SUMMARY STATISTICS

JAN. 2014

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jan. 2013 of export proceeds and import payments:

Export proceeds totaled US\$ 25,979.9 million, a decrease of US\$ 2,400.8 million or 8.5% (Table 1), as compared with Jan. 2013.

Import payments totaled US\$ 22,506.1 million, a decrease of US\$ 3,555.1 million or 13.6% (Table 1), as compared with Jan. 2013.

3. Comparison with Jan. 2013 of export proceeds realized:

Sold for N.T. Dollars US\$ 2,062.5 million, a decrease of US\$ 105.1 million or 4.8% (Table 2), as compared with Jan. 2013.

Retained with exporters US\$ 23,917.4 million, a decrease of US\$ 2,295.7 million or 8.8% (Table 2), as compared with Jan. 2013.

4. Comparison with Jan. 2013 of import payments made:

Purchased with N.T. Dollars US\$ 3,815.7 million, a decrease of US\$ 676.9 million or 15.1% (Table 3), as compared with Jan. 2013.

Self-acquired foreign exchange imports US\$ 18,690.4 million, a decrease of US\$ 2,878.2 million or 13.3% (Table 3), as comparison with Jan. 2013.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

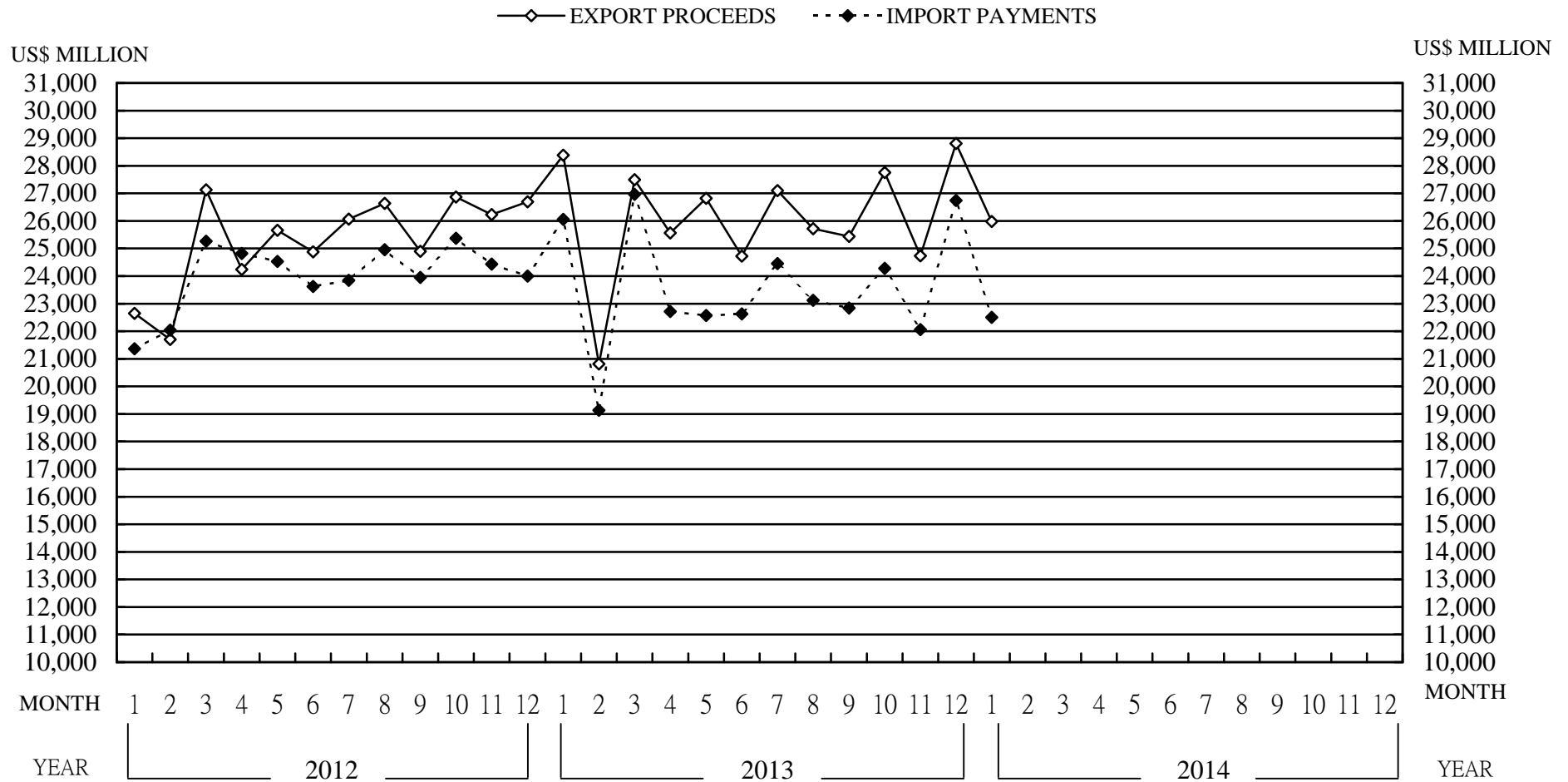
