

# SUMMARY STATISTICS

JAN. 2011

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jan. 2010 of export proceeds and import payments:

Export proceeds totaled US\$ 24,308.6 million, an increase of US\$ 5,044.1 million or 26.2% (Table 1), as compared with Jan. 2010.

Import payments totaled US\$ 23,562.1 million, an increase of US\$ 5,346.8 million or 29.4% (Table 1), as compared with Jan. 2010.

3. Comparison with Jan. 2010 of export proceeds realized:

Sold for N.T. Dollars US\$ 2,183.2 million, an increase of US\$ 563.0 million or 34.7% (Table 2), as compared with Jan. 2010.

Retained with exporters US\$ 22,125.4 million, an increase of US\$ 4,481.1 million or 25.4% (Table 2), as compared with Jan. 2010.

4. Comparison with Jan. 2010 of import payments made:

Purchased with N.T. Dollars US\$ 4,180.7 million, an increase of US\$ 612.7 million or 17.2% (Table 3), as compared with Jan. 2010.

Self-acquired foreign exchange imports US\$ 19,381.4 million, an increase of US\$ 4,734.1 million or 32.3% (Table 3), as compared with Jan. 2010.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 2,082.8 million, 8.6% of total exports.

Usance L/C US\$ 819.6 million, 3.4% of total exports.

Collection US\$ 352.2 million, 1.4% of total exports.

Remittance US\$ 21,054.0 million, 86.6% of total exports.

(2) Imports:

Sight L/C US\$ 702.9 million, 3.0% of total imports.

Usance L/C US\$ 3,272.6 million, 13.9% of total imports.

Collection US\$ 206.0 million, 0.9% of total imports.

Remittance US\$ 19,380.6 million, 82.2% of total imports.




