

# SUMMARY STATISTICS

APR. 2011

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Apr. 2010 of export proceeds and import payments:

Export proceeds totaled US\$ 25,132.0 million, an increase of US\$ 3,202.7 million or 14.6% (Table 1), as compared with Apr. 2010.

Import payments totaled US\$ 24,940.4 million, an increase of US\$ 3,875.1 million or 18.4% (Table 1), as compared with Apr. 2010.

3. Comparison with Apr. 2010 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,868.0 million, an increase of US\$ 46.7 million or 2.6% (Table 2), as compared with Apr. 2010.

Retained with exporters US\$ 23,264.0 million, an increase of US\$ 3,156.0 million or 15.7% (Table 2), as compared with Apr. 2010.

4. Comparison with Apr. 2010 of import payments made:

Purchased with N.T. Dollars US\$ 4,569.7 million, an increase of US\$ 781.7 million or 20.6% (Table 3), as compared with Apr. 2010.

Self-acquired foreign exchange imports US\$ 20,370.7 million, an increase of US\$ 3,093.4 million or 17.9% (Table 3), as compared with Apr. 2010.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 2,476.2 million, 9.9% of total exports.

Usance L/C US\$ 759.4 million, 3.0% of total exports.

Collection US\$ 363.9 million, 1.4% of total exports.

Remittance US\$ 21,532.5 million, 85.7% of total exports.

(2) Imports:

Sight L/C US\$ 444.8 million, 1.8% of total imports.

Usance L/C US\$ 3,829.2 million, 15.4% of total imports.

Collection US\$ 260.9 million, 1.0% of total imports.

Remittance US\$ 20,405.5 million, 81.8% of total imports.




