SUMMARY STATISTICS

JUL, 2016

- 1. Coverage of Statistics:
 - All foreign exchange export proceeds and import payments through banks.
- 2. Comparison with Jul. 2015 of export proceeds and import payments:
 - Export proceeds totaled US\$ 20,404.0 million, a decrease of US\$ 4,102.1 million or 16.7% (Table 1), as compared with Jul. 2015.
 - Import payments totaled US\$ 16,587.3 million, a decrease of US\$ 1,961.3 million or 10.6% (Table 1), as compared with Jul. 2015.
- 3. Comparison with Jul. 2015 of export proceeds realized:
 - Sold for N.T. Dollars US\$ 1,308.0 million, a decrease of US\$ 524.5 million or 28.6% (Table 2), as compared with Jul. 2015.
 - Retained with exporters US\$ 19,096.0 million, a decrease of US\$ 3,577.6 million or 15.8% (Table 2), as compared with Jul. 2015.
- 4. Comparison with Jul. 2015 of import payments made:
 - Purchased with N.T. Dollars US\$ 3,168.5 million, a decrease of US\$ 213.9 million or 6.3% (Table 3), as compared with Jul. 2015.
 - Self-acquired foreign exchange imports US\$ 13,418.8 million, a decrease of US\$ 1,747.4 million or 11.5% (Table 3), as comparison with Jul. 2015.
