

SUMMARY STATISTICS

JUN. 2012

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jun. 2011 of export proceeds and import payments:

Export proceeds totaled US\$ 24,882.0 million, a decrease of US\$ 3,189.8 million or 11.4% (Table 1), as compared with Jun. 2011.

Import payments totaled US\$ 23,624.6 million, a decrease of US\$ 2,909.5 million or 11.0% (Table 1), as compared with Jun. 2011.

3. Comparison with Jun. 2011 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,978.9 million, a decrease of US\$ 266.7 million or 11.9% (Table 2), as compared with Jun. 2011.

Retained with exporters US\$ 22,903.1 million, a decrease of US\$ 2,923.1 million or 11.3% (Table 2), as compared with Jun. 2011.

4. Comparison with Jun. 2011 of import payments made:

Purchased with N.T. Dollars US\$ 4,178.9 million, a decrease of US\$ 443.1 million or 9.6% (Table 3), as compared with Jun. 2011.

Self-acquired foreign exchange imports US\$ 19,445.7 million, a decrease of US\$ 2,466.4 million or 11.3% (Table 3), as comparison with Jun. 2011.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 2,042.3 million, 8.2% of total exports.

Usance L/C US\$ 766.4 million, 3.1% of total exports.

Collection US\$ 402.2 million, 1.6% of total exports.

Remittance US\$ 21,671.1 million, 87.1% of total exports.

(2) Imports:

Sight L/C US\$ 425.3 million, 1.8% of total imports.

Usance L/C US\$ 2,897.3 million, 12.3% of total imports.

Collection US\$ 206.4 million, 0.9% of total imports.

Remittance US\$ 20,095.6 million, 85.0% of total imports.



