

# SUMMARY STATISTICS

JUN. 2015

**1. Coverage of Statistics:**

All foreign exchange export proceeds and import payments through banks.

**2. Comparison with Jun. 2014 of export proceeds and import payments:**

Export proceeds totaled US\$ 24,015.2 million, a decrease of US\$ 2,028.6 million or 7.8% (Table 1), as compared with Jun. 2014.

Import payments totaled US\$ 19,173.9 million, a decrease of US\$ 5,161.9 million or 21.2% (Table 1), as compared with Jun. 2014.

**3. Comparison with Jun. 2014 of export proceeds realized:**

Sold for N.T. Dollars US\$ 1,726.0 million, a decrease of US\$ 93.2 million or 5.1% (Table 2), as compared with Jun. 2014.

Retained with exporters US\$ 22,289.2 million, a decrease of US\$ 1,935.4 million or 8.0% (Table 2), as compared with Jun. 2014.

**4. Comparison with Jun. 2014 of import payments made:**

Purchased with N.T. Dollars US\$ 3,664.6 million, a decrease of US\$ 826.3 million or 18.4% (Table 3), as compared with Jun. 2014.

Self-acquired foreign exchange imports US\$ 15,509.3 million, a decrease of US\$ 4,335.6 million or 21.8% (Table 3), as comparison with Jun. 2014.

**5. Foreign exchange exports and imports by type of payment (Table 4):**

**(1) Exports:**

Sight L/C US\$ 1,597.0 million, 6.6% of total exports.

Usance L/C US\$ 713.9 million, 3.0% of total exports.

Collection US\$ 273.6 million, 1.1% of total exports.

Remittance US\$ 21,430.7 million, 89.3% of total exports.

**(2) Imports:**

Sight L/C US\$ 431.2 million, 2.2% of total imports.

Usance L/C US\$ 2,447.9 million, 12.8% of total imports.

Collection US\$ 261.1 million, 1.4% of total imports.

Remittance US\$ 16,033.7 million, 83.6% of total imports.

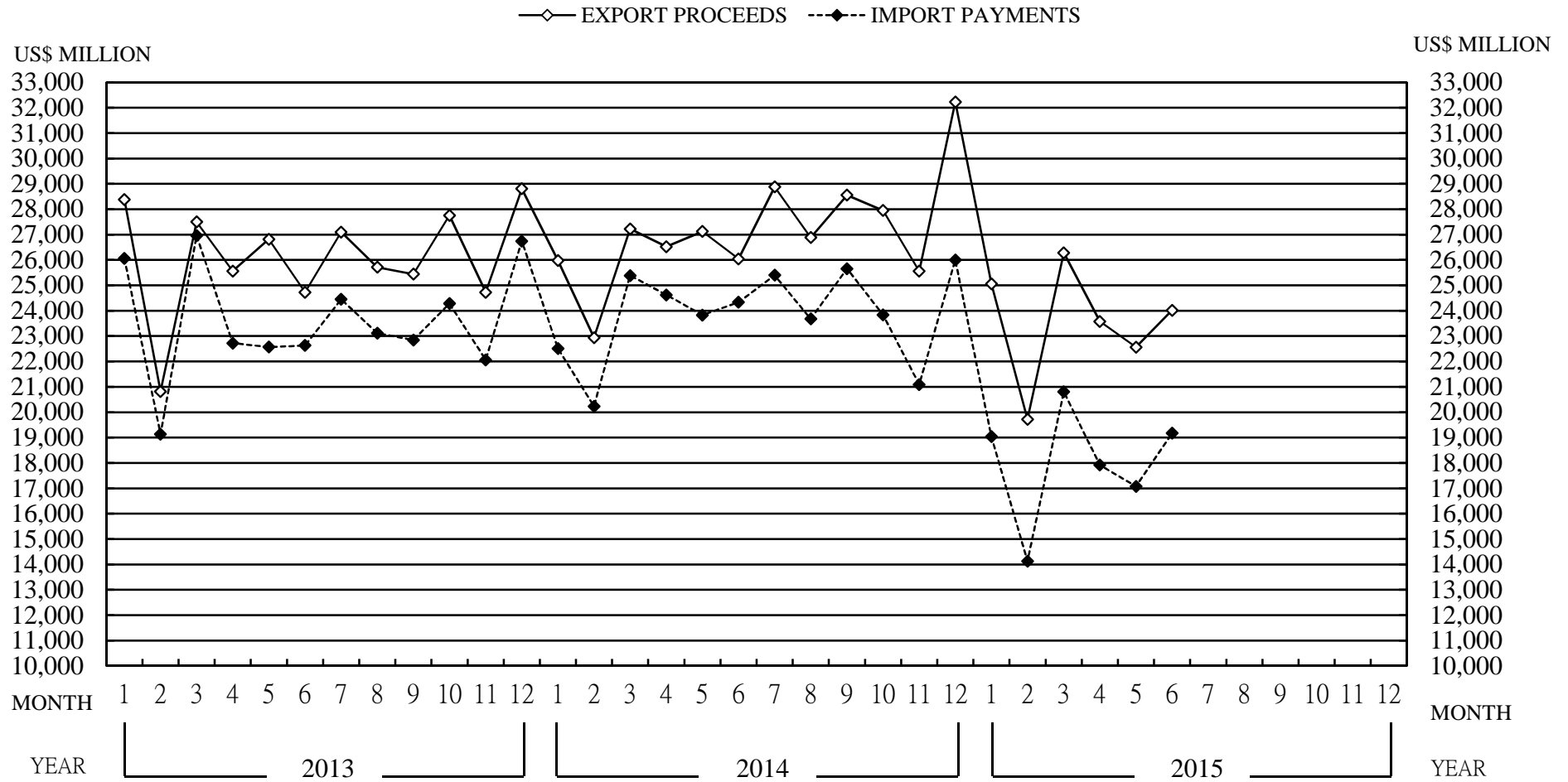

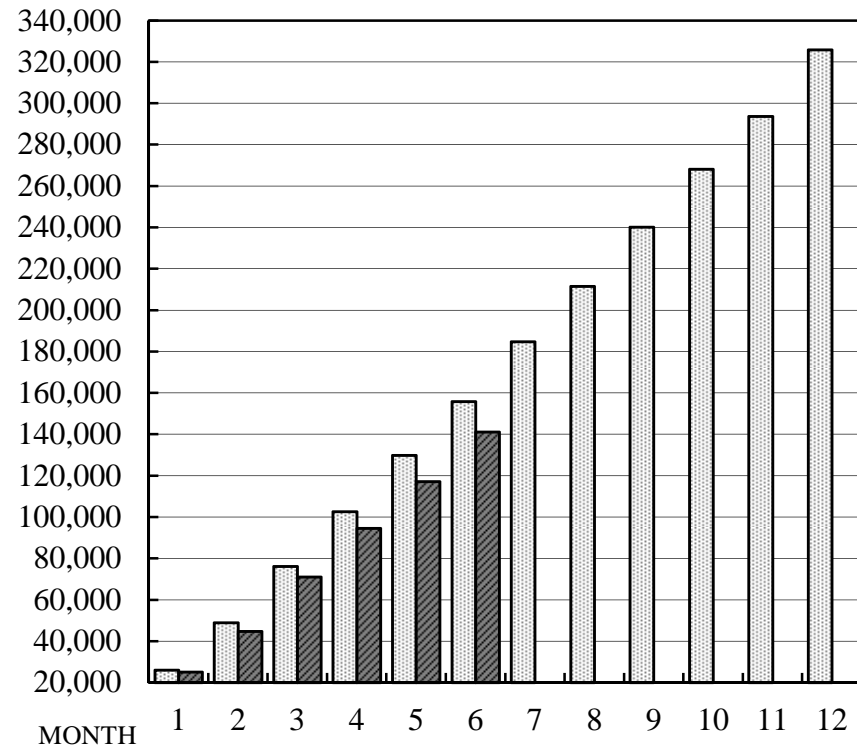
