

SUMMARY STATISTICS

DEC. 2012

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Dec. 2011 of export proceeds and import payments:

Export proceeds totaled US\$ 26,693.7 million, a decrease of US\$ 609.1 million or 2.2% (Table 1), as compared with Dec. 2011.

Import payments totaled US\$ 24,004.0 million, a decrease of US\$ 2,048.9 million or 7.9% (Table 1), as compared with Dec. 2011.

3. Comparison with Dec. 2011 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,853.2 million, a decrease of US\$ 266.9 million or 12.6% (Table 2), as compared with Dec. 2011.

Retained with exporters US\$ 24,840.5 million, a decrease of US\$ 342.2 million or 1.4% (Table 2), as compared with Dec. 2011.

4. Comparison with Dec. 2011 of import payments made:

Purchased with N.T. Dollars US\$ 4,554.0 million, a decrease of US\$ 589.8 million or 11.5% (Table 3), as compared with Dec. 2011.

Self-acquired foreign exchange imports US\$ 19,450.0 million, a decrease of US\$ 1,459.1 million or 7.0% (Table 3), as comparison with Dec. 2011.

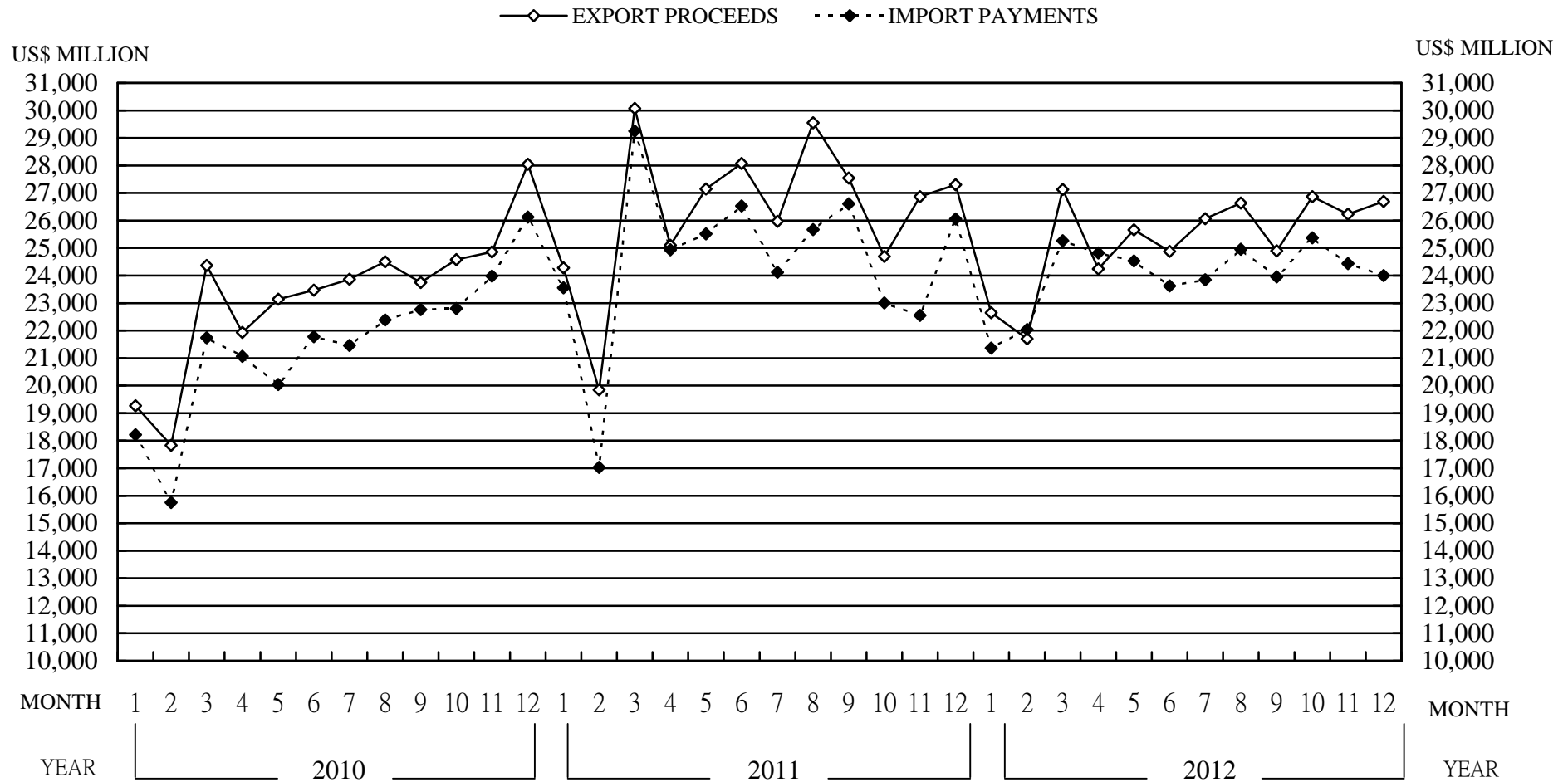
