

SUMMARY STATISTICS

NOV. 2012

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Nov. 2011 of export proceeds and import payments:

Export proceeds totaled US\$ 26,229.3 million, a decrease of US\$ 633.8 million or 2.4% (Table 1), as compared with Nov. 2011.

Import payments totaled US\$ 24,455.5 million, an increase of US\$ 1,900.5 million or 8.4% (Table 1), as compared with Nov. 2011.

3. Comparison with Nov. 2011 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,840.4 million, a decrease of US\$ 369.3 million or 16.7% (Table 2), as compared with Nov. 2011.

Retained with exporters US\$ 24,388.9 million, a decrease of US\$ 264.5 million or 1.1% (Table 2), as compared with Nov. 2011.

4. Comparison with Nov. 2011 of import payments made:

Purchased with N.T. Dollars US\$ 4,160.4 million, a decrease of US\$ 390.9 million or 8.6% (Table 3), as compared with Nov. 2011.

Self-acquired foreign exchange imports US\$ 20,295.1 million, an increase of US\$ 2,291.4 million or 12.7% (Table 3), as comparison with Nov. 2011.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 2,097.1 million, 8.0% of total exports.

Usance L/C US\$ 795.6 million, 3.0% of total exports.

Collection US\$ 325.9 million, 1.2% of total exports.

Remittance US\$ 23,010.7 million, 87.8% of total exports.

(2) Imports:

Sight L/C US\$ 319.8 million, 1.3% of total imports.

Usance L/C US\$ 2,991.5 million, 12.2% of total imports.

Collection US\$ 192.6 million, 0.8% of total imports.

Remittance US\$ 20,951.6 million, 85.7% of total imports.

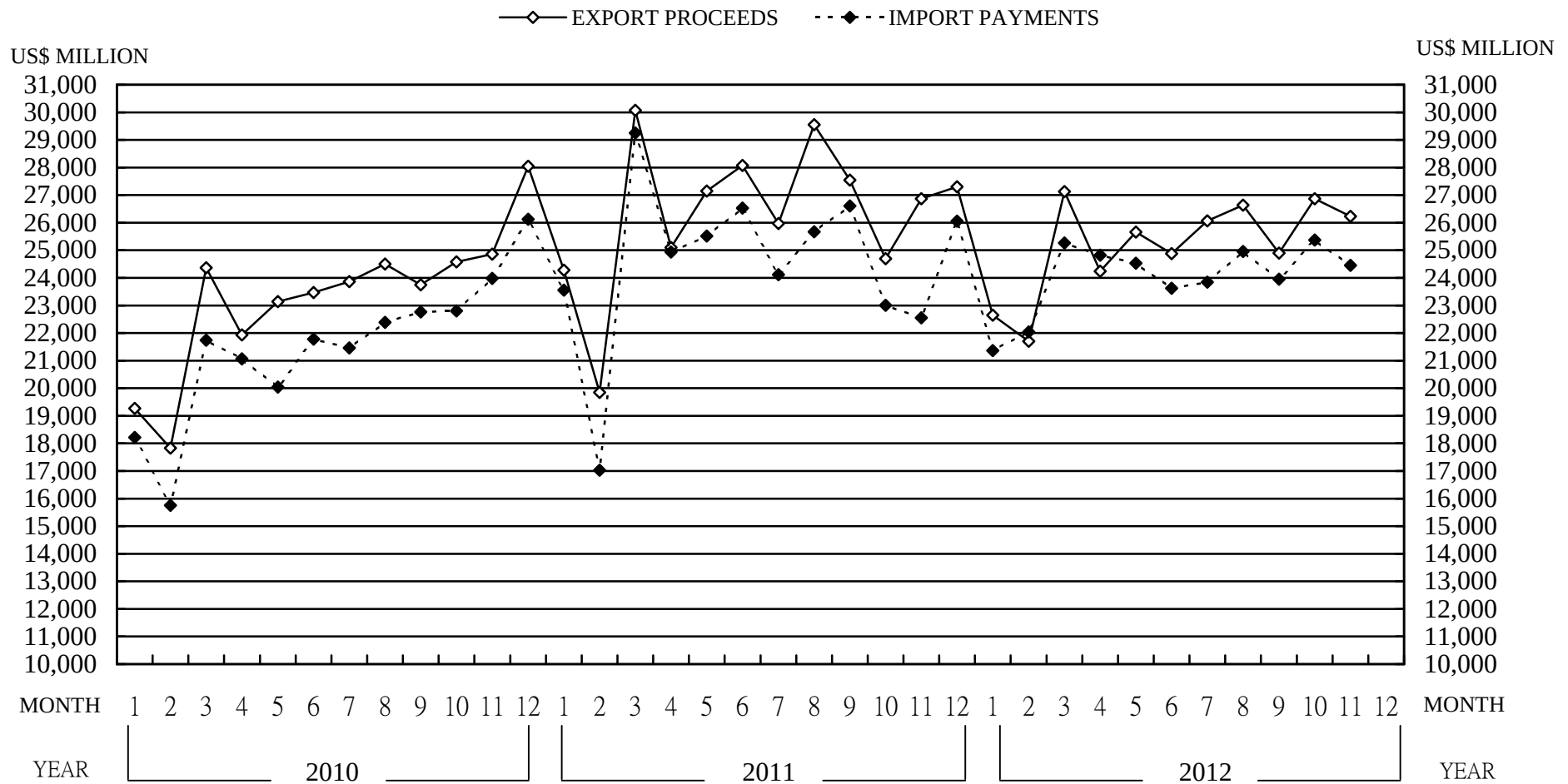
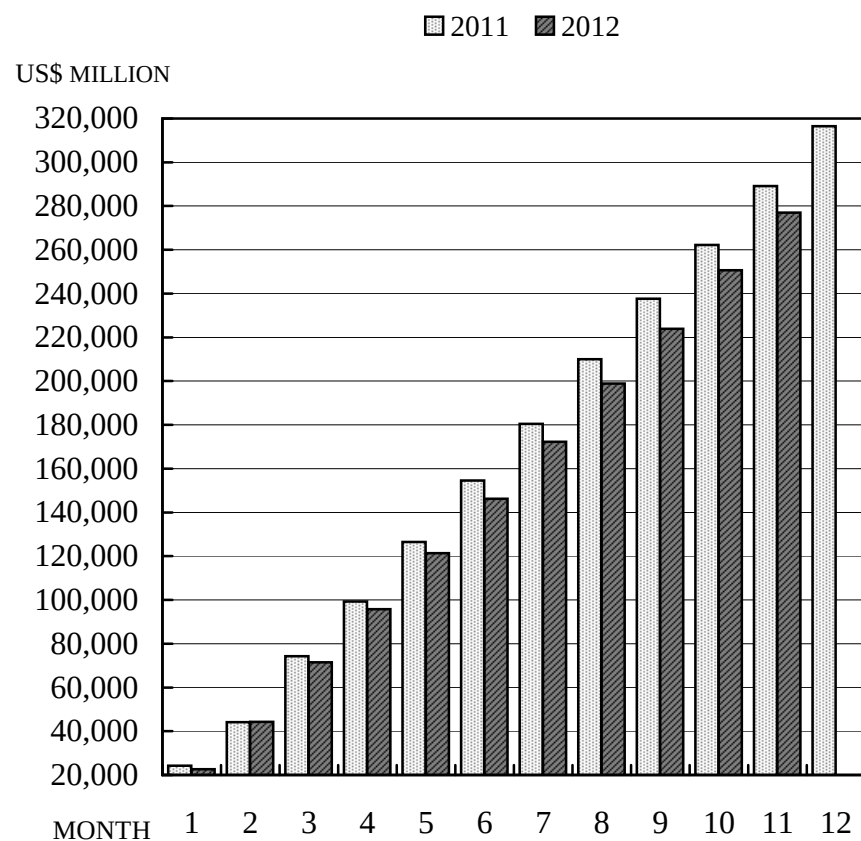
