

SUMMARY STATISTICS

FEB. 2013

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Feb. 2012 of export proceeds and import payments:

Export proceeds totaled US\$ 20,820.0 million, a decrease of US\$ 884.1 million or 4.1% (Table 1), as compared with Feb. 2012.

Import payments totaled US\$ 19,135.8 million, a decrease of US\$ 2,904.5 million or 13.2% (Table 1), as compared with Feb. 2012.

3. Comparison with Feb. 2012 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,481.8 million, a decrease of US\$ 308.3 million or 17.2% (Table 2), as compared with Feb. 2012.

Retained with exporters US\$ 19,338.2 million, a decrease of US\$ 575.8 million or 2.9% (Table 2), as compared with Feb. 2012.

4. Comparison with Feb. 2012 of import payments made:

Purchased with N.T. Dollars US\$ 3,062.0 million, a decrease of US\$ 863.1 million or 22.0% (Table 3), as compared with Feb. 2012.

Self-acquired foreign exchange imports US\$ 16,073.8 million, a decrease of US\$ 2,041.4 million or 11.3% (Table 3), as comparison with Feb. 2012.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C	US\$	1,770.1 million,	8.5% of total exports.
Usance L/C	US\$	581.5 million,	2.8% of total exports.
Collection	US\$	258.8 million,	1.2% of total exports.

(2) Imports:

Remittance	US\$	16,557.2 million,	86.6% of total imports.

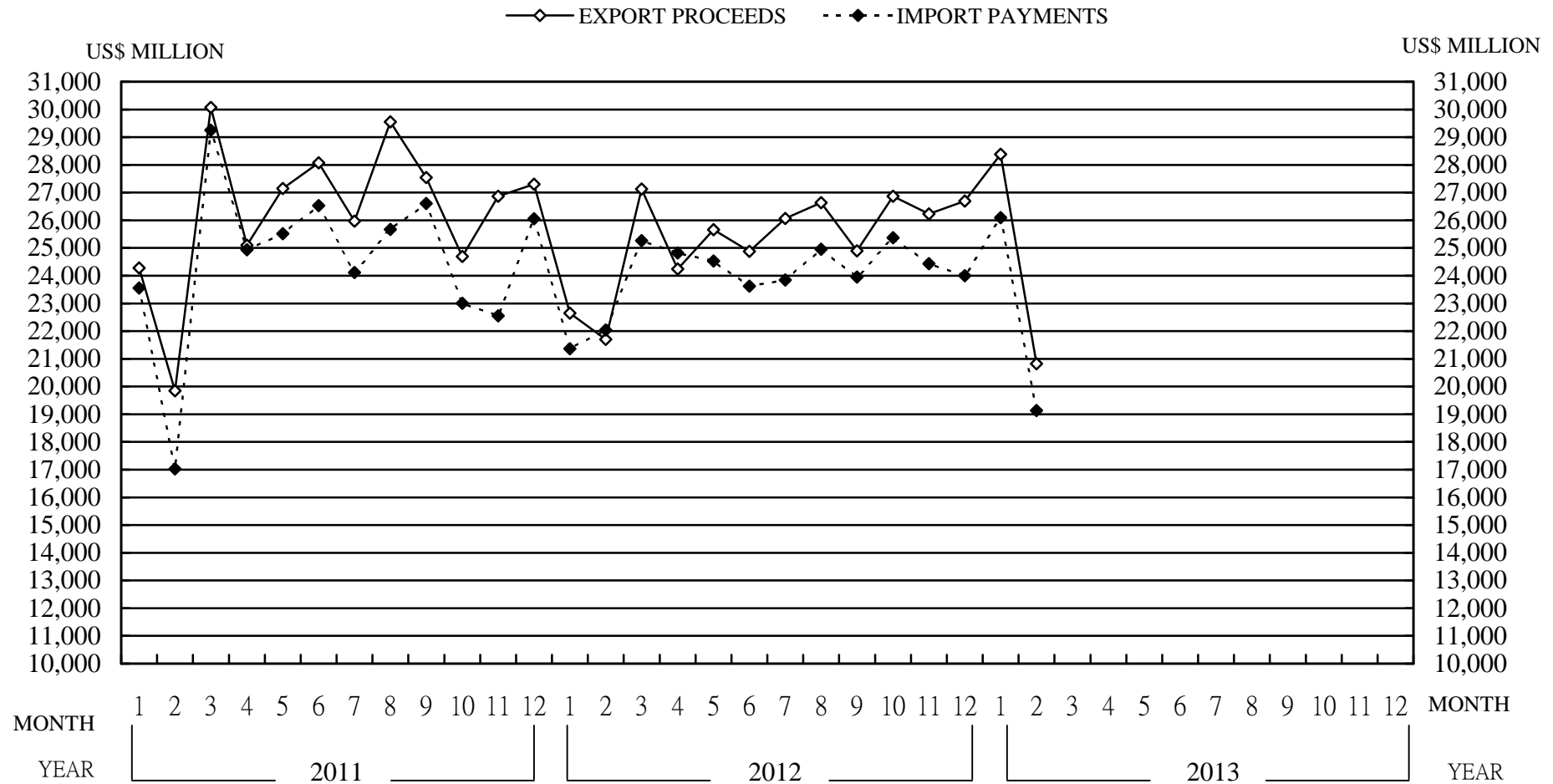
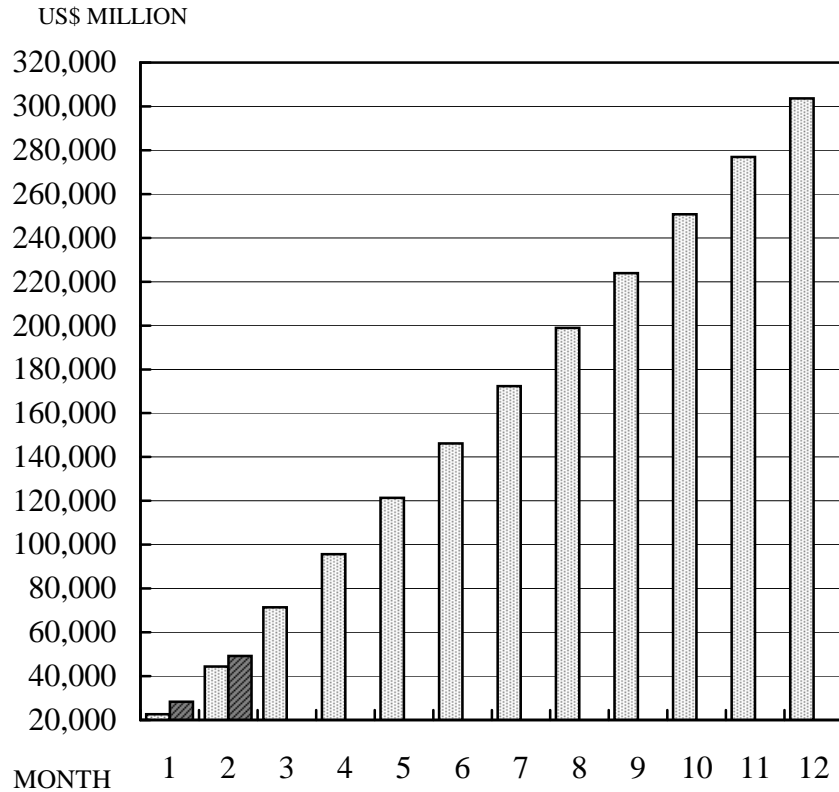
