

SUMMARY STATISTICS

NOV. 2015

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Nov. 2014 of export proceeds and import payments:

Export proceeds totaled US\$ 22,252.4 million, a decrease of US\$ 3,307.3 million or 12.9% (Table 1), as compared with Nov. 2014.

Import payments totaled US\$ 16,833.8 million, a decrease of US\$ 4,253.4 million or 20.2% (Table 1), as compared with Nov. 2014.

3. Comparison with Nov. 2014 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,397.9 million, a decrease of US\$ 513.0 million or 26.8% (Table 2), as compared with Nov. 2014.

Retained with exporters US\$ 20,854.5 million, a decrease of US\$ 2,794.3 million or 11.8% (Table 2), as compared with Nov. 2014.

4. Comparison with Nov. 2014 of import payments made:

Purchased with N.T. Dollars US\$ 3,502.5 million, a decrease of US\$ 256.1 million or 6.8% (Table 3), as compared with Nov. 2014.

Self-acquired foreign exchange imports US\$ 13,331.3 million, a decrease of US\$ 3,997.3 million or 23.1% (Table 3), as comparison with Nov. 2014.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 1,278.5 million, 5.7% of total exports.

Usance L/C US\$ 533.6 million, 2.4% of total exports.

Collection US\$ 216.2 million, 1.0% of total exports.

Remittance US\$ 20,224.1 million, 90.9% of total exports.

(2) Imports:

Sight L/C US\$ 229.8 million, 1.4% of total imports.

Usance L/C US\$ 2,055.1 million, 12.2% of total imports.

Collection US\$ 156.1 million, 0.9% of total imports.

Remittance US\$ 14,392.8 million, 85.5% of total imports.

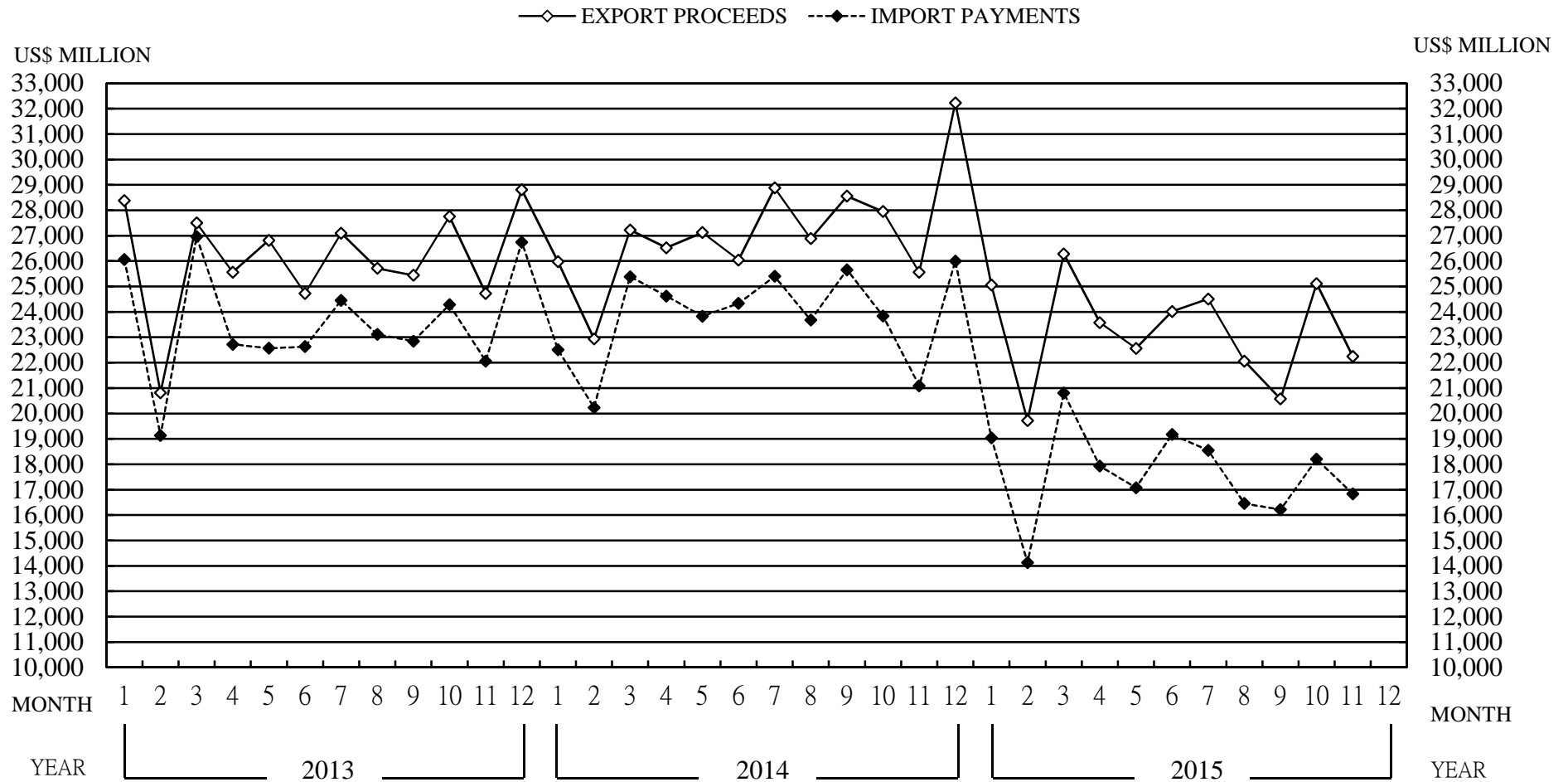
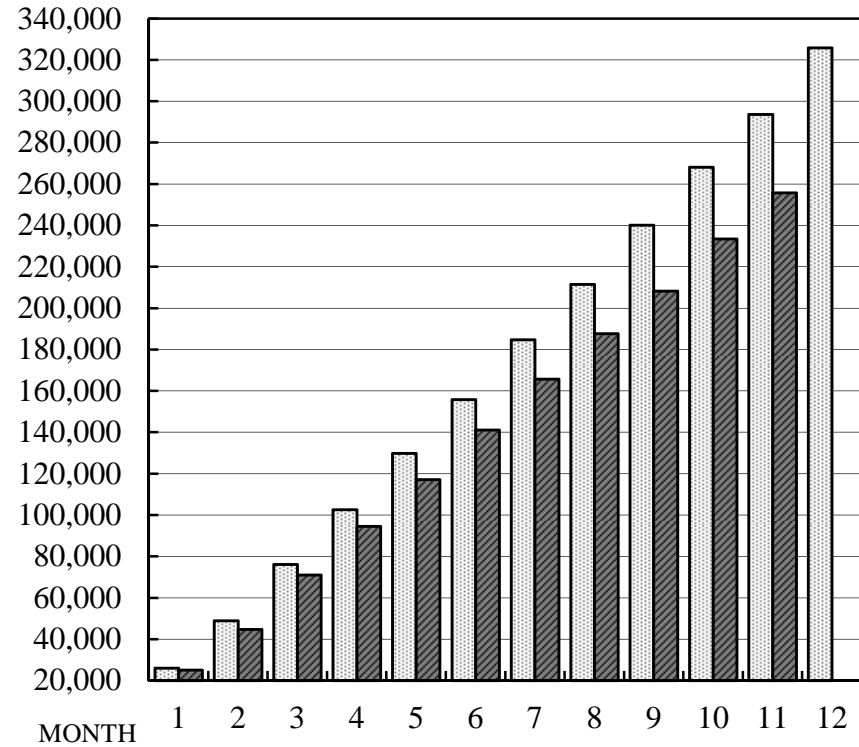
