

SUMMARY STATISTICS

NOV. 2014

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Nov. 2013 of export proceeds and import payments:

Export proceeds totaled US\$ 25,564.0 million, an increase of US\$ 834.6 million or 3.4% (Table 1), as compared with Nov. 2013.

Import payments totaled US\$ 21,088.1 million, a decrease of US\$ 974.4 million or 4.4% (Table 1), as compared with Nov. 2013.

3. Comparison with Nov. 2013 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,910.9 million, an increase of US\$ 120.8 million or 6.7% (Table 2), as compared with Nov. 2013.

Retained with exporters US\$ 23,653.1 million, an increase of US\$ 713.8 million or 3.1% (Table 2), as compared with Nov. 2013.

4. Comparison with Nov. 2013 of import payments made:

Purchased with N.T. Dollars US\$ 3,758.6 million, an increase of US\$ 72.6 million or 2.0% (Table 3), as compared with Nov. 2013.

Self-acquired foreign exchange imports US\$ 17,329.5 million, a decrease of US\$ 1,047.0 million or 5.7% (Table 3), as comparison with Nov. 2013.

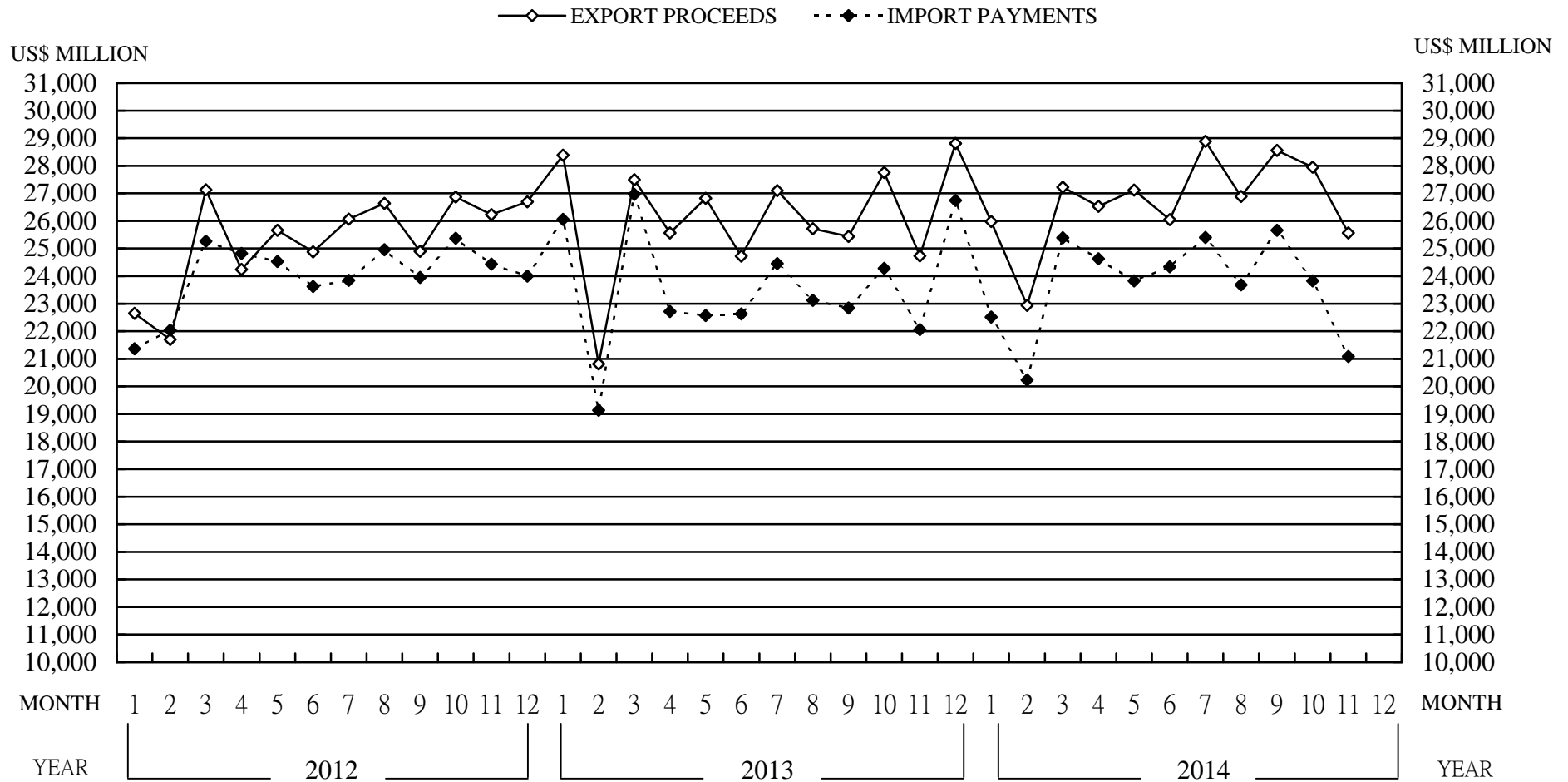
