

# SUMMARY STATISTICS

JUN. 2008

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jun. 2007 of export proceeds and import payments:

Export proceeds totaled US\$ 23,264.3 million, an increase of US\$ 3,389.4 million or 17.1% (Table 1), as compared with Jun. 2007.

Import payments totaled US\$ 24,338.9 million, an increase of US\$ 5,086.6 million or 26.4% (Table 1), as compared with Jun. 2007.

3. Comparison with Jun. 2007 of export proceeds realized:

Sold for N.T. Dollars US\$ 2,220.6 million, an increase of US\$ 73.6 million or 3.4% (Table 2), as compared with Jun. 2007.

Retained with exporters US\$ 21,043.7 million, an increase of US\$ 3,315.8 million or 18.7% (Table 2), as compared with Jun. 2007.

4. Comparison with Jun. 2007 of import payments made:

Purchased with N.T. Dollars US\$ 4,927.8 million, an increase of US\$ 664.1 million or 15.6% (Table 3), as compared with Jun. 2007.

Self-acquired foreign exchange imports US\$ 19,411.1 million, an increase of US\$ 4,422.5 million or 29.5% (Table 3), as compared with Jun. 2007.

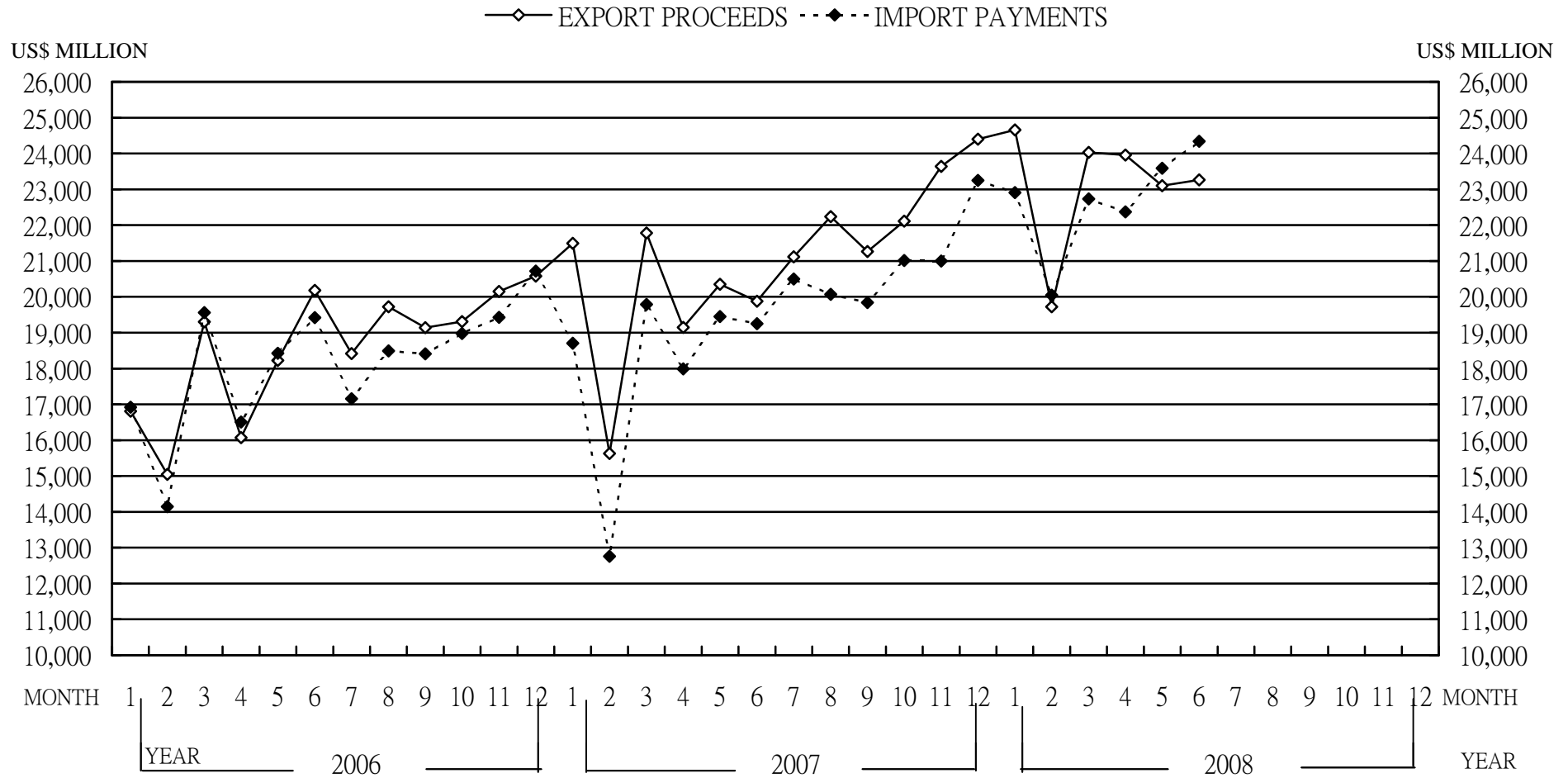
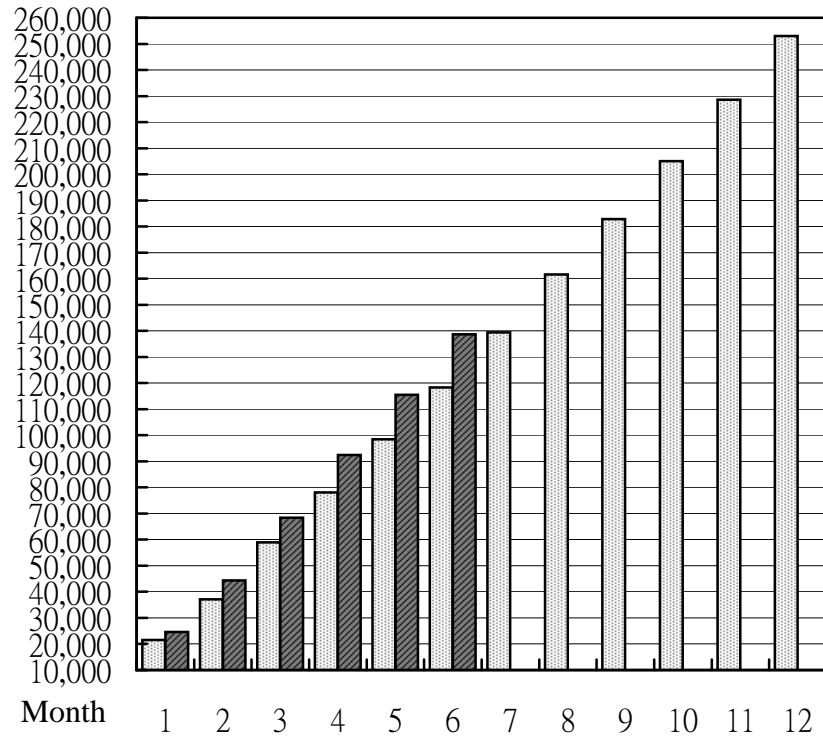
