

SUMMARY STATISTICS

APR. 2020

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Apr. 2019 of export proceeds and import payments:

Export proceeds totaled US\$ 22,834.8 million, a decrease of US\$ 323.2 million or 1.4% (Table 1), as compared with Apr. 2019.

Import payments totaled US\$ 17,745.6 million, a decrease of US\$ 299.6 million or 1.7% (Table 1), as compared with Apr. 2019.

3. Comparison with Apr. 2019 of export proceeds realized:

Sold for N.T. Dollars US\$ 913.5 million, a decrease of US\$ 388.8 million or 29.9% (Table 2), as compared with Apr. 2019.

Retained with exporters US\$ 21,921.3 million, an increase of US\$ 65.6 million or 0.3% (Table 2), as compared with Apr. 2019.

4. Comparison with Apr. 2019 of import payments made:

Purchased with N.T. Dollars US\$ 3,690.8 million, an increase of US\$ 58.1 million or 1.6% (Table 3), as compared with Apr. 2019.

Self-acquired foreign exchange imports US\$ 14,054.8 million, a decrease of US\$ 357.7 million or 2.5% (Table 3), as comparison with Apr. 2019.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 860.9 million, 3.8% of total exports.

Usance L/C US\$ 366.1 million, 1.6% of total exports.

Collection US\$ 191.9 million, 0.8% of total exports.

Remittance US\$ 21,415.9 million, 93.8% of total exports.

(2) Imports:

Sight L/C US\$ 193.5 million, 1.1% of total imports.

Usance L/C US\$ 1,867.8 million, 10.5% of total imports.

Collection US\$ 176.7 million, 1.0% of total imports.

Remittance US\$ 15,507.6 million, 87.4% of total imports.

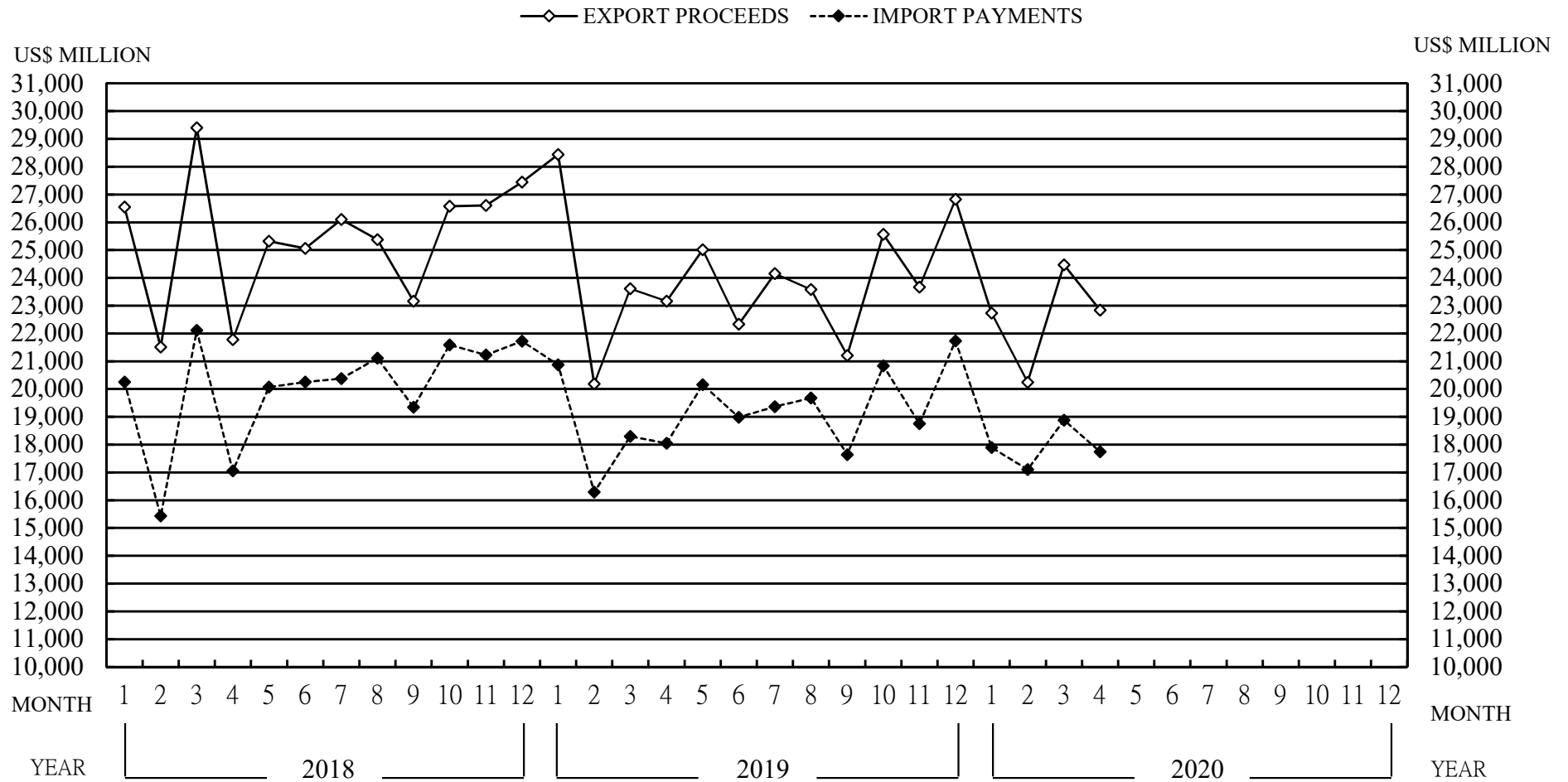
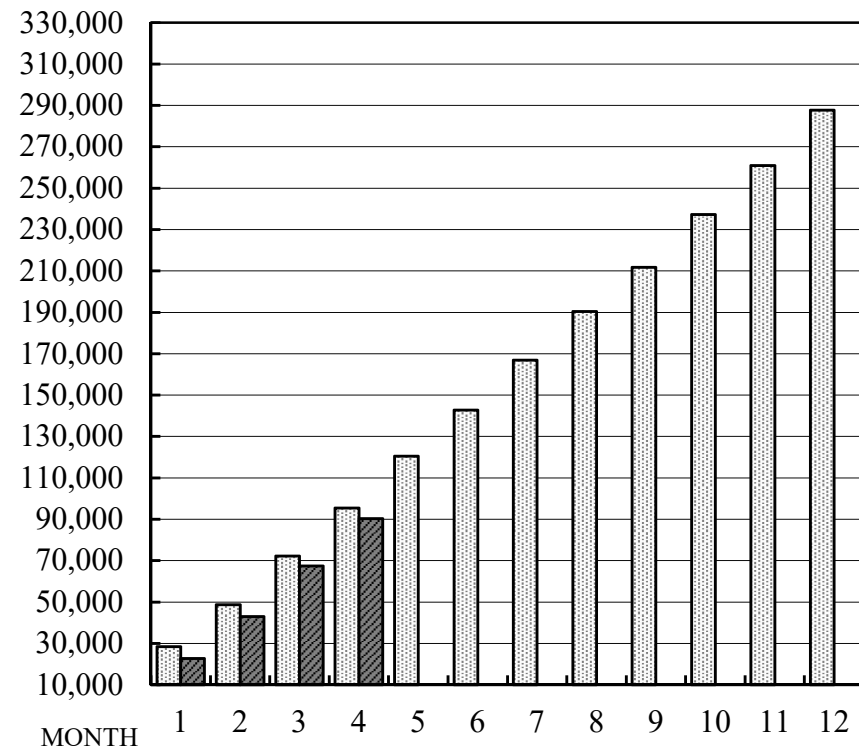
