

# SUMMARY STATISTICS

JUN. 2021

**1. Coverage of Statistics:**

All foreign exchange export proceeds and import payments through banks.

**2. Comparison with Jun. 2020 of export proceeds and import payments:**

Export proceeds totaled US\$ 31,368.2 million, an increase of US\$ 8,179.2 million or 35.3% (Table 1), as compared with Jun. 2020.

Import payments totaled US\$25,487.5 million, an increase of US\$ 8,536.3 million or 50.4% (Table 1), as compared with Jun. 2020.

**3. Comparison with Jun. 2020 of export proceeds realized:**

Sold for N.T. Dollars US\$ 1,432.7an increase of US\$ 505.754.619,982.2 (Table 2), as compared with Jun. 2020.

Retained with exporters US\$ 29,935.5an increase of US\$ 7,673.534.519,982.2 (Table 2), as compared with Jun. 2020.

**4. Comparison with Jun. 2020 of import payments made:**

Purchased with N.T. Dollars US\$ 4,667.0an increase of US\$ 1,122.831.719,982.2 (Table 3), as compared with Jun. 2020.

Self-acquired foreign exchange imports US\$ 20,820.5an increase of US\$ 7,413.555.319,982.2 (Table 3), as comparison with Jun. 2020.

**5. Foreign exchange exports and imports by type of payment (Table 4):**

**(1) Exports:**

Sight L/C US\$ 1,182.3 million, 3.8% of total exports.

Usance L/C US\$ 575.8 million, 1.8% of total exports.

Collection US\$ 242.4 million, 0.8% of total exports.

Remittance US\$ 29,367.7 million, 93.6% of total exports.

**(2) Imports:**

Sight L/C US\$ 253.2 million, 1.0% of total imports.

Usance L/C US\$ 2,141.0 million, 8.4% of total imports.

Collection US\$ 180.4 million, 0.7% of total imports.

Remittance US\$ 22,912.9 million, 89.9% of total imports.

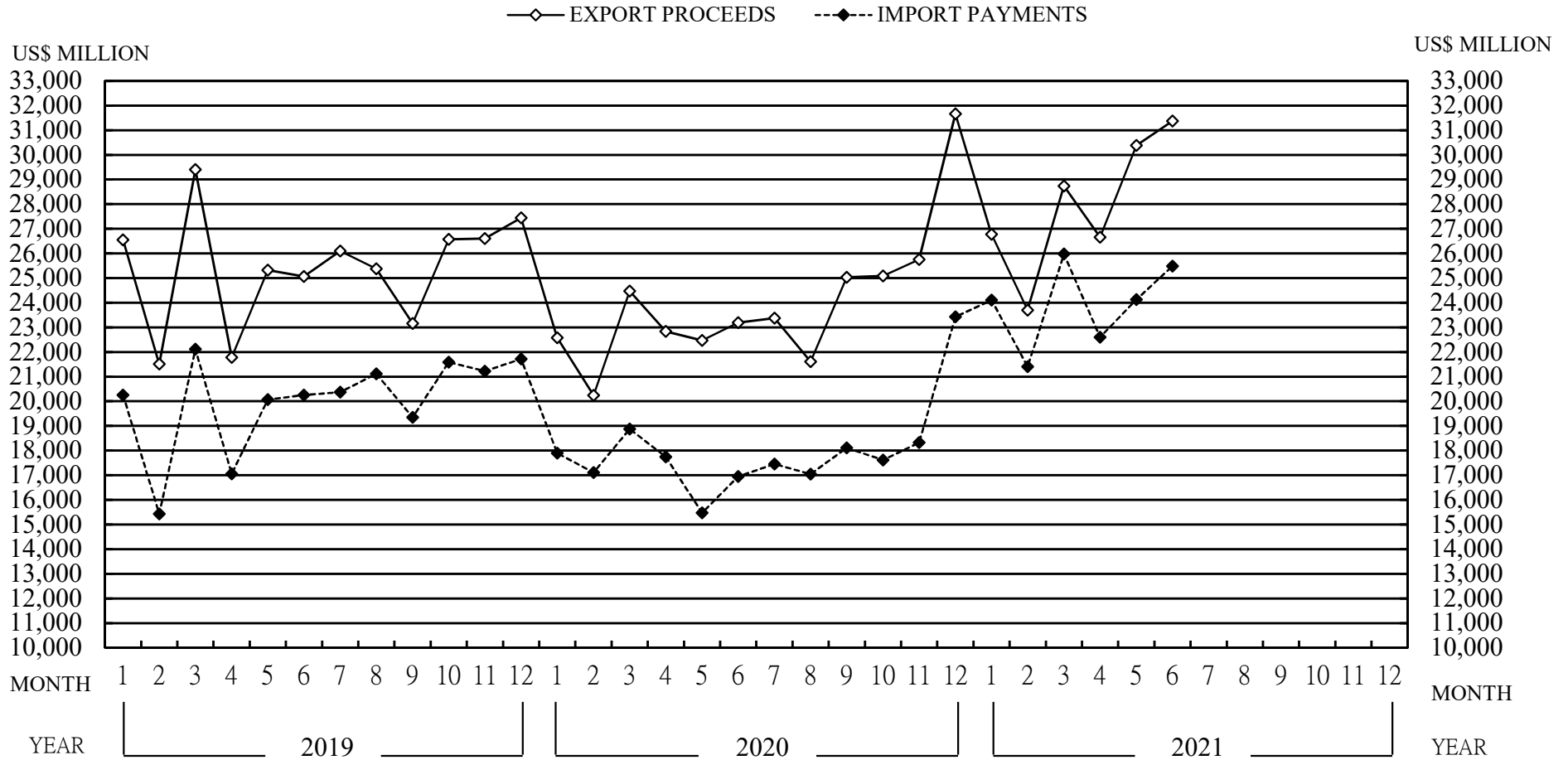

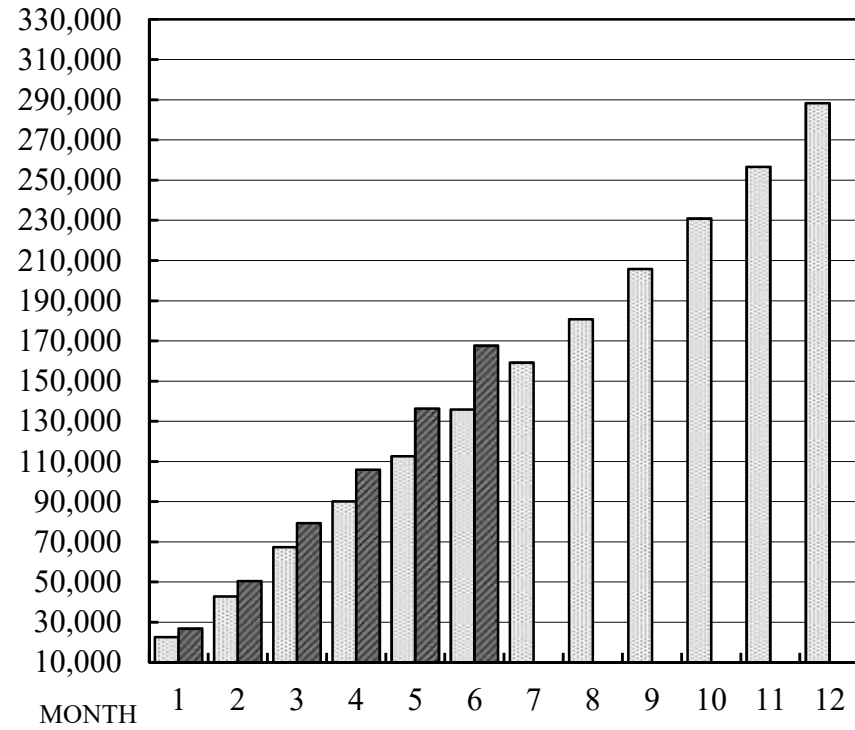
