## **SUMMARY STATISTICS**

#### JAN. 2022

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jan. 2021 of export proceeds and import payments:

Export proceeds totaled US\$ 30,227.5 million, an increase of US\$ 4,269.6 million or 16.4% (Table 1), as compared with Jan. 2021.

Import payments totaled US\$ 29,319.7 million, an increase of US\$ 5,212.5 million or 21.6% (Table 1), as compared with Jan. 2021.

3. Comparison with Jan. 2021 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,511.8 million, an increase of US\$ 146.1 million or 10.7% (Table 2), as compared with Jan. 2021.

Retained with exporters US\$ 28,715.7 million, an increase of US\$ 4,123.5 million or 16.8% (Table 2), as compared with Jan. 2021.

4. Comparison with Jan. 2021 of import payments made:

Purchased with N.T. Dollars US\$ 29,319.7 million, an increase of US\$ 854.1 million or 23.1% (Table 3), as compared with Jan. 2021.

Self-acquired foreign exchange imports US\$ 24,764.0 million, an increase of US\$ 4,358.4 million or 21.4% (Table 3), as comparison with Jan. 2021.


