

SUMMARY STATISTICS

AUG. 2025

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Aug. 2024 of export proceeds and import payments:

Export proceeds totaled US\$ 30,406.9 million, a decrease of US\$ 963.2 million or 3.1% (Table 1), as compared with Aug. 2024.

Import payments totaled US\$ 27,456.7 million, an increase of US\$ 2,245.0 million or 8.9% (Table 1), as compared with Aug. 2024.

3. Comparison with Aug. 2024 of export proceeds realized:

Sold for N.T. Dollars US\$ 920.5 million, a decrease of US\$ 48.5 million or 5.0% (Table 2), as compared with Aug. 2024.

Retained with exporters US\$ 29,486.4 million, a decrease of US\$ 914.7 million or 3.0% (Table 2), as compared with Aug. 2024.

4. Comparison with Aug. 2024 of import payments made:

Purchased with N.T. Dollars US\$ 4,327.1 million, a decrease of US\$ 236.9 million or 5.2% (Table 3), as compared with Aug. 2024.

Self-acquired foreign exchange imports US\$ 23,129.6 million, an increase of US\$ 2,481.9 million or 12.0% (Table 3), as comparison with Aug. 2024.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 684.9 million, 2.3% of total exports.

Usance L/C US\$ 439.4 million, 1.4% of total exports.

Collection US\$ 118.7 million, 0.4% of total exports.

Remittance US\$ 29,163.9 million, 95.9% of total exports.

(2) Imports:

Sight L/C US\$ 162.1 million, 0.6% of total imports.

Usance L/C US\$ 1,341.6 million, 4.9% of total imports.

Collection US\$ 128.2 million, 0.5% of total imports.

Remittance US\$ 25,824.8 million, 94.0% of total imports.

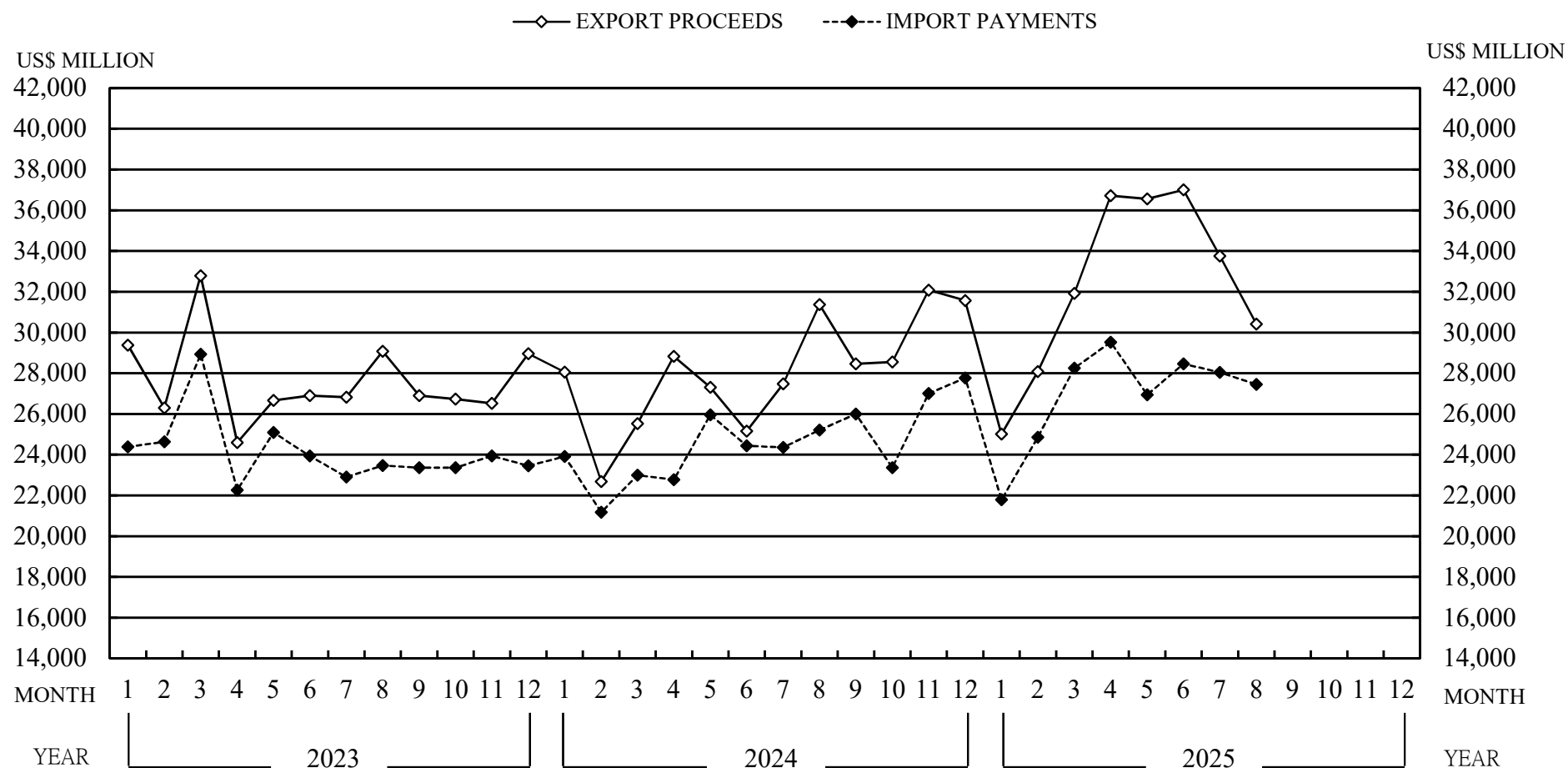
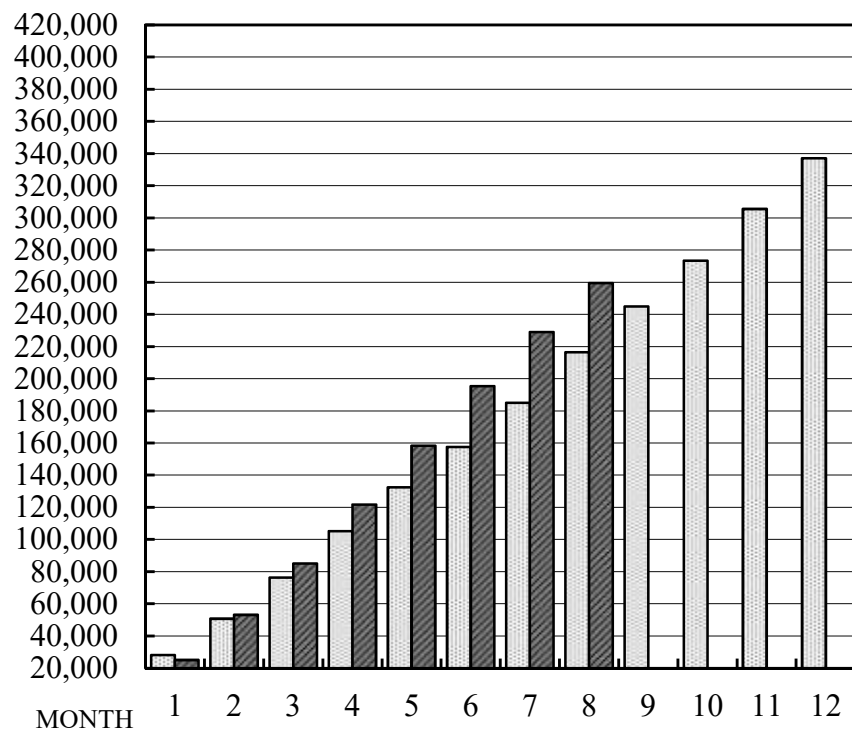
