

SUMMARY STATISTICS

NOV. 2025

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Nov. 2024 of export proceeds and import payments:

Export proceeds totaled US\$ 36,278.2 million, an increase of US\$ 4,196.0 million or 13.1% (Table 1), as compared with Nov. 2024.

Import payments totaled US\$ 28,494.7 million, an increase of US\$ 1,486.3 million or 5.5% (Table 1), as compared with Nov. 2024.

3. Comparison with Nov. 2024 of export proceeds realized:

Sold for N.T. Dollars US\$ 913.8 million, a decrease of US\$ 108.0 million or 10.6% (Table 2), as compared with Nov. 2024.

Retained with exporters US\$ 35,364.4 million, an increase of US\$ 4,304.0 million or 13.9% (Table 2), as compared with Nov. 2024.

4. Comparison with Nov. 2024 of import payments made:

Purchased with N.T. Dollars US\$ 4,091.8 million, a decrease of US\$ 366.2 million or 8.2% (Table 3), as compared with Nov. 2024.

Self-acquired foreign exchange imports US\$ 24,402.9 million, an increase of US\$ 1,852.5 million or 8.2% (Table 3), as comparison with Nov. 2024.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C US\$ 623.4 million, 1.7% of total exports.

Usance L/C US\$ 344.5 million, 0.9% of total exports.

Collection US\$ 87.4 million, 0.2% of total exports.

Remittance US\$ 35,222.9 million, 97.2% of total exports.

(2) Imports:

Sight L/C US\$ 145.5 million, 0.5% of total imports.

Usance L/C US\$ 1,303.6 million, 4.6% of total imports.

Collection US\$ 126.8 million, 0.4% of total imports.

Remittance US\$ 26,918.8 million, 94.5% of total imports.

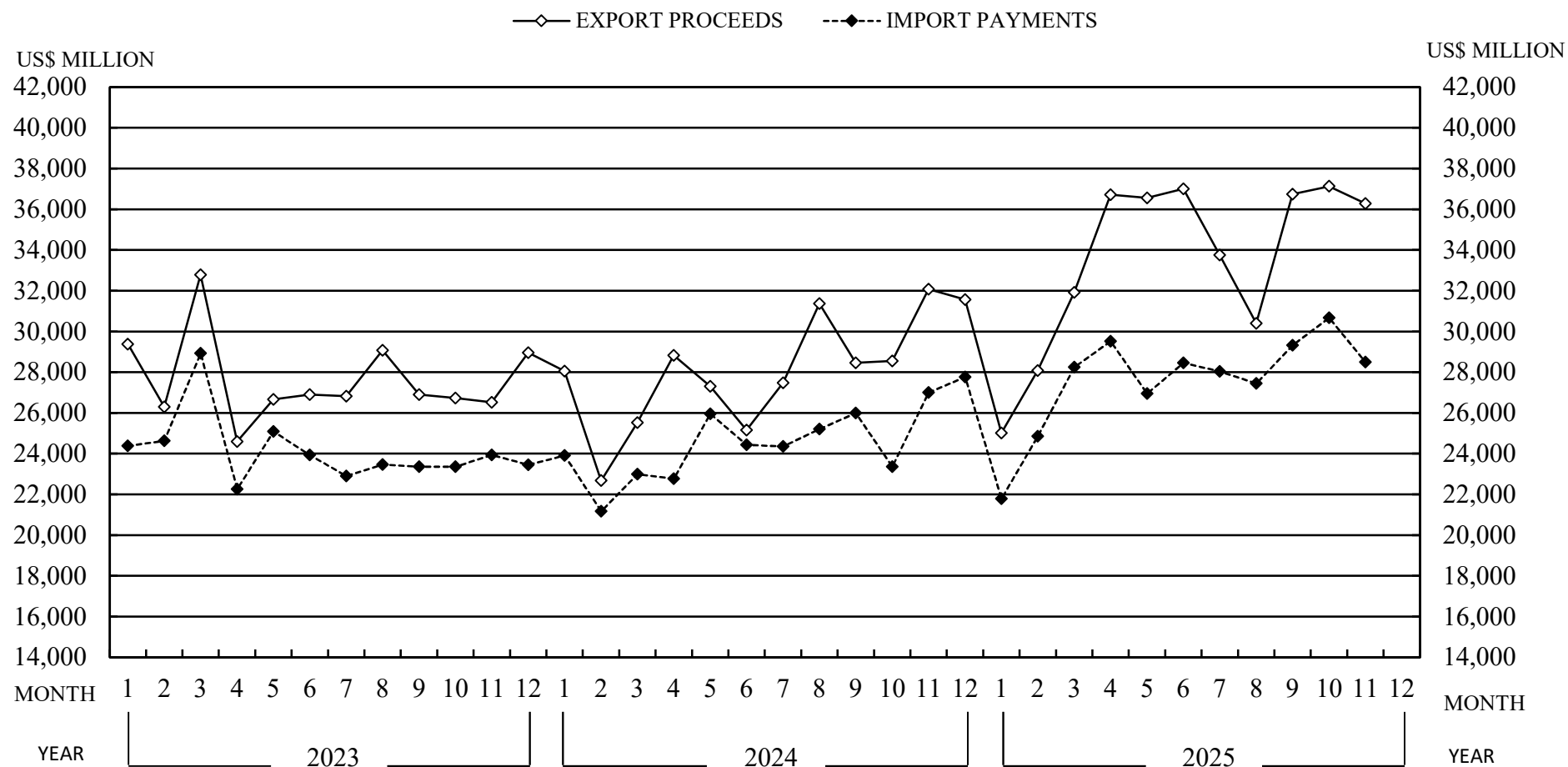
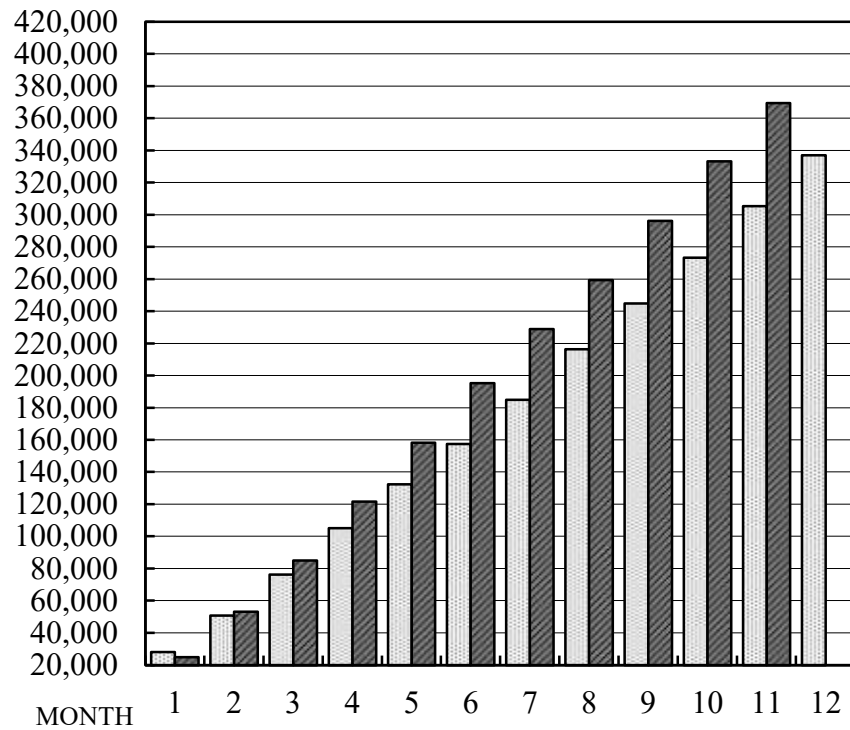
