

SUMMARY STATISTICS

JAN. 2018

1. Coverage of Statistics:

All foreign exchange export proceeds and import payments through banks.

2. Comparison with Jan. 2017 of export proceeds and import payments:

Export proceeds totaled US\$ 26,551.8 million, an increase of US\$ 5,456.2 million or 25.9% (Table 1), as compared with Jan. 2017.

Import payments totaled US\$ 20,254.5 million, an increase of US\$ 4,337.3 million or 27.2% (Table 1), as compared with Jan. 2017.

3. Comparison with Jan. 2017 of export proceeds realized:

Sold for N.T. Dollars US\$ 1,497.6 million, an increase of US\$ 354.7 million or 31.0% (Table 2), as compared with Jan. 2017.

Retained with exporters US\$ 25,054.2 million, an increase of US\$ 5,101.5 million or 25.6% (Table 2), as compared with Jan. 2017.

4. Comparison with Jan. 2017 of import payments made:

Purchased with N.T. Dollars US\$ 3,942.7 million, an increase of US\$ 469.1 million or 13.5% (Table 3), as compared with Jan. 2017.

Self-acquired foreign exchange imports US\$ 16,311.8 million, an increase of US\$ 3,868.2 million or 31.1% (Table 3), as comparison with Jan. 2017.

5. Foreign exchange exports and imports by type of payment (Table 4):

(1) Exports:

Sight L/C	US\$	1,734.1 million,	6.5% of total exports.
Usance L/C	US\$	574.6 million,	2.2% of total exports.
Collection	US\$	276.2 million,	1.0% of total exports.
Remittance	US\$	23,966.9 million,	90.3% of total exports.

(2) Imports:

Sight L/C	US\$	244.9 million,	1.2% of total imports.
Usance L/C	US\$	2,087.3 million,	10.3% of total imports.
Collection	US\$	170.9 million,	0.8% of total imports.
Remittance	US\$	17,751.4 million,	87.7% of total imports.

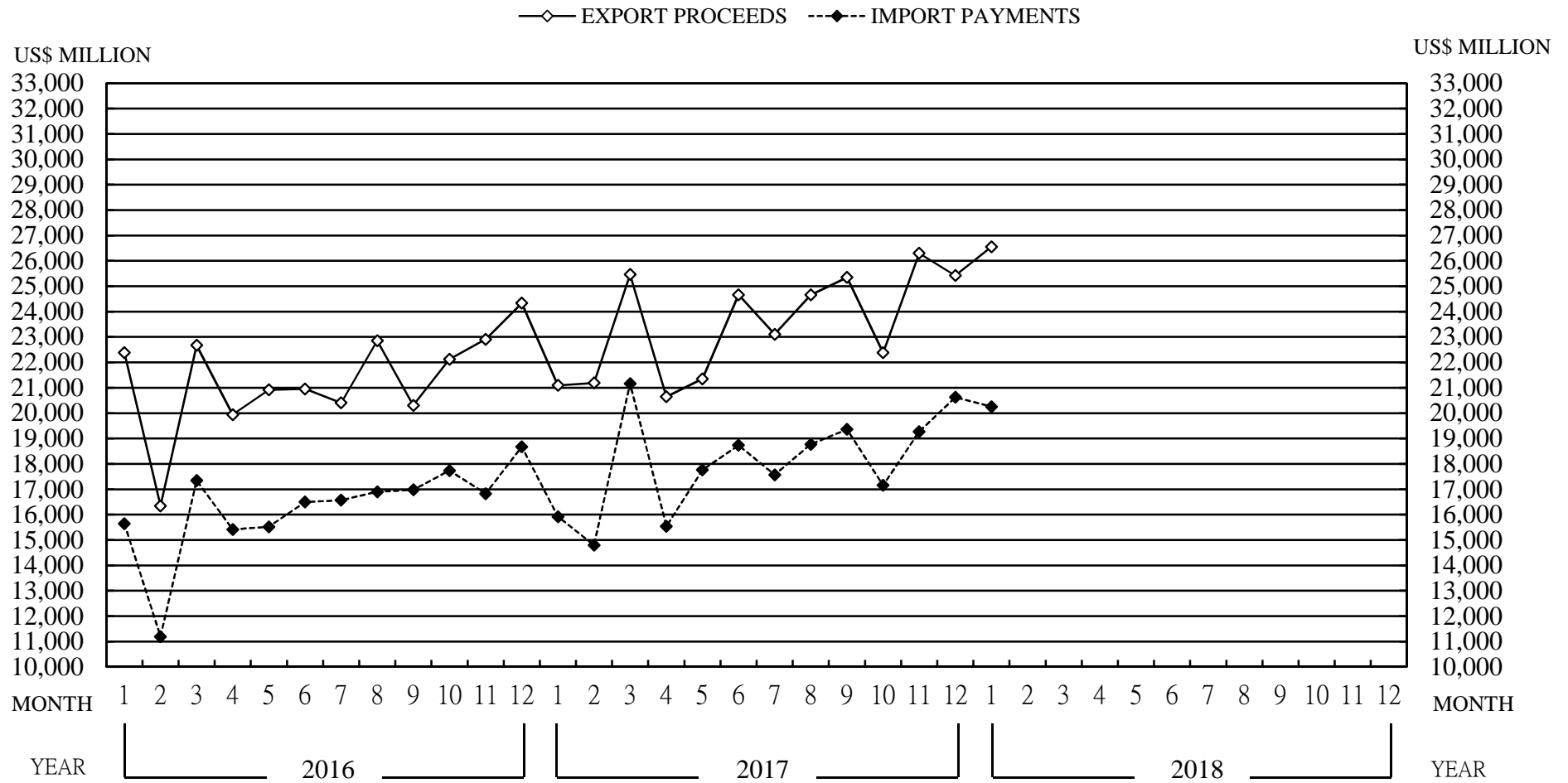
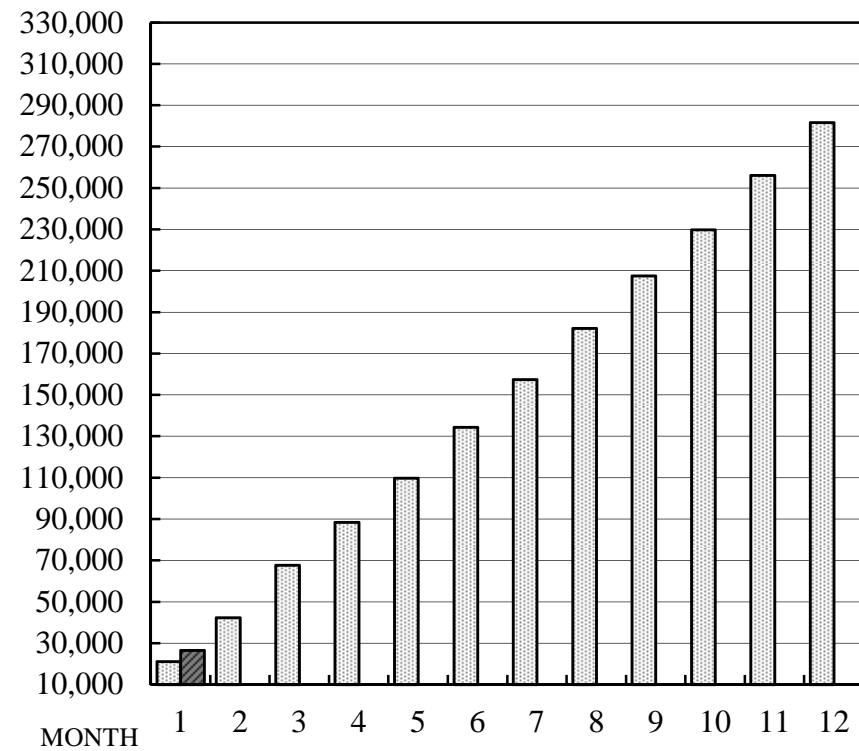
